David Montes de Oca, Coordinator, Office of Charter Schools, stated it is staff's recommendation to negotiate with the school to withdraw its charter renewal petition request which would otherwise require decisionmaking by the State Administrator at the February 25, 2009 Board Meeting, given that no further extensions are allowed under the law and to resubmit their charter renewal request with a subsequent submission to staff for review and evaluation of a Strategic Improvement Plan, to be included for further consideration with respect to charter renewal decisionmaking. If the charter school is to be considered for renewal decisionmaking at this time in the absence of an Improvement Plan for review, it is the recommendation of staff to deny the charter renewal petition as set forth in the OUSD Charter Renewal Standards. The current charter will expire on June 30, 2009. Mr. Montes noted attendance rate has improved at OASIS to 92.5 percent.

In response to Director Hodge, State Administrator Matthews said in most cases, he supports the staff recommendation. He visits Charter Schools on a regular basis. He believes what is in the report to be fair, credible and accurate. Superintendent Mayor stated we did participate in the review of OASIS. The review process is a very rigorous process. The recommendation is very sound because it provides the school with an option for the school.

Hugo Arabia, Principal, OASIS High School, spoke on this item. He supports the recommendation. The school has been in existence for four-and-one-half years and there has been a big improvement. This is a good way for them to develop an accountability report and improvement plan and they are ready to move in that direction. They want to show data and assessment and they want to improve in those areas.

Logan Manning, teacher, OASIS, stated they want to improve the teaching at the school. The biggest flaw is that they cannot strategically plan for students and meet the academic needs of their students. They will develop standards based assessments and a strategic plan.

Allison McLean said they are looking at the situation as an opportunity. The school has a very high level of commitment by the Board of Directors. There is an ongoing Board commitment to be involved in the strategic planning process. They plan to be involved at every direction and they have \$5,000 earmarked for a literacy coach.

Mr. Montes de Oca said the staff's recommendation would provide the school with an opportunity and permission to have an Improvement Plan introduced subsequent to the charter renewal request.

Director Hodge commented on the process and going back and creating opportunities for

charter schools applying for renewal. There is a nuance that she is speaking about and it is important for us to pay attention to and talk to our fellow colleagues about.

David Montes de Oca, Coordinator, Office of Charter Schools, stated that the evaluation was focused on the K-5 Program. Millsmont has met or made substantial program in student attendance, API Growth and participation by students in co-extracurricular activities. Millsmont Academy is a BLUE school based on OUSD tiering. It is GREEN in its two-vear growth and GREEN in its three-vear CST performance.

Mr. Montes de Oca stated it is staff's recommendation to approval the Charter Renewal as revised because the charter has met the standards and expectations set forth in the OUSD Charter Renewal Standards which are based on the standards and criteria set forth in the Charter Schools Act. David Montes de Oca, Coordinator, Office of Charter Schools, reviewed staff report which is to approve the Monarch Academy charter renewal as revised because the charter has met the standards and expectations set forth in the OUSD Charter Renewal Standards which are based on the standards and criteria set forth in the Charter Schools Act, Education Code Section 47605. The revisions are included in APPENDIX I. Mr. Montes de Oca said Monarch has made substantial progress in meeting its charter goals and has accelerated the goals as outlined in the staff report. It is a BLUE school based on OUSD tiering. It is a GREEN school on its one year growth, GREEN in its two-year growth and GREEN in its three-year growth on CST performance. The school has demonstrated steady and continuous growth in student CST performance in both English Language Arts and mathematics, increasing proficient and advanced levels by 19 percent over a three-year period. Acceleration rates in ELA have met or exceeded those required by California to meet AYP. The school has met its AYP targets for the past three years. Mr. Montes de Oca said like the other schools reviwed tody, three percent of their students are in Special Education.

Cecilia Smith, a parent, said she is extremely pleased with the staff. They know her child by her first name. The school is very structured.

Tatiana Epanchin, Principal, responded to Board Member questions. Director Hodge asked about the dip in ELA. Ms. Epondrin said one of the factors was that she was limited in adding six teachers and many teachers did not become full time until January 2008. The school did not focus on all the right things as a school. She plans to change the

structure of teacher planning time and to plan for ELA.

Director Hodge asked about the low number of students served in Special Education. Ms. Epanchin stated their kids are not labeled Special Education unless it is for speech and language. When they do the IEPs, they ensure the goals are appropriate. The school offers "reading recovery". They have 100 students who have one-on-one intervention sessions for 20 weeks with Resource Specialists at the school.

Director Dobbins noted that Charter Schools do not accept a lot of Special Education students.

A motion was made by Jumoke Hinton Hodge, seconded by Christopher Dobbins, that this matter be Recommended Favorably. The motion carried by the following vote:

Restructuring of Instructional Program and Redesignation of Facilities Housing Tilden School

Approval by the State Administrator and Board of Education of Joint Resolution No. 0809-0141 - Approving the restructuring of the Tilden School Instructional Program and the redesignation of physical facilities necessary to house such restructured instructional program effective July 1, 2010 and to include monthly meetings with Tilden staff and PTO for successful resolution.

Brad Stam used a PowerPoint Presentation for the Tilden Relocation Update. Tilden serves 125 students serving 93 Pre Kindergarten SDC students, 80 K-3 SDC students, and 45 K-3 General Education students. In 2007-08 Tilden went through a redesign process, primarily to rebalance the SCE and General Education populations and enhance the educational program. In Spring 2008, at the end of the redesign phase, major facilities issues were identified at Tilden that resulted in significant repair and relocation needs. In Spring 2008 Cabinet decided to vacate lower Tilden due to multiple significant facilities issues. In Spring 2008, an agreement was reached to review long-term solutions. In December 2008, the Board of Education approved for staff to engage with Tilden

community and review relocation options for 2009-10.

The significant issues involve facility issues of a difficult terrain and very challenging accessibility issues for special needs students. There is a need to repair fire alarm and PA systems. There is a forest location conducive to continuous high moisture and potential for mold and faster deterioration of buildings. There is a lack of barrier or fencing to off-site premises. To renovate upper Tilden would include new floors, painting, fencing, restroom restoration, heater installation, fire and alarm systems, at a cost estimate of one million dollars.

The engagement process was held during March - May 2008 and included five meetings with the principal and staff from Facilities, School Portfolio Management, NEXO, and Cabinet. From October-February 2009, Tilden subcommittee meetings were held with teachers, parents, principals, and staff from Facilities, School Portfolio, NEXO and Cabinet. Parent letters were sent home in June 2008 and December 2008. There was a parent and community meeting on January 13, 2009. There were walkthroughs held in January and February 2009 by Facilities staff, relocation site principals, and Tilden parent leaders.

The relocation factors include meeting the needs of students and having a continuum of service at each location; SPED/General Education balance of students at each site; and Site Capacity at relocation site. The relocation consists of placement of 16 Tilden SDC programs and assignments for the General Education students. No one location could house all programs based on facility constraints.

The Tilden Relocation Proposal includes adding the PreK LE SDC and K LE SDC Tilden Program at Bella Vista;

adding the PreK Autism SDC, K-2 Autism SDC, 3-5 Autism SDC, PreK SH SDC, and K SH SDC Tilden Programs at Brookfield;

adding the PreK SH SDC, PreK Autism SDC, PreK LE, K LE, and K-2 Autism SDC to Burckhalter;

and adding the PreK Autism SDC, PreK LE, K-2 Autism SDC Program to Howard.

The estimated cost at Bella Vista would be \$10,000; at Brookfield \$25,000; at Howard \$15,000 respectively.

Recommendation is to approve Tilden Relocation Plan; communication to parents regarding outcome; assignment of teachers, and facilities timeline and process for moves.

Mr. Stam said the estimated cost for Burckhalter would be \$700,000 to install four portables with a need for plumbing in each of those four portables for accessibility and other miscellaneous costs. The initial estimate was given by our Facilities Department.

Shannon Gason, parent of a four-year-old student, spoke of the quality of education at Tilden. She said for autistic children, visuals are everything. She questioned whether there has been sufficient time to perform an assessment.

Angelica Lopez-Fasce, parent, said the process is taking place too fast. The parents have not been shown that the new schools will meet their needs. Does the new schools have the same type of equipment?

Jodi Brooks, teacher, said she is concerned about the quality of education. Tilden is a school where parents feel safe. Children need to feel welcomed. The staff is dedicated and they work together and share ideas. Tilden is a model school.

Cintya Molina, parent, spoke of the facility challenges and problem with pollution.

Wefaa Aborashed, Healthy 880 Communities, said that autism is caused by pollution and asked that we not bring anymore kids into that neighborhood.

Kristen Dixon, parent, said her son was injured on the play structure because there were no mats. She asked what is the rush to relocate Tilden.

Victor Gasion, parent, said that parents are unaware of the proposed move and the move does not allow enough time. Her daughter now speaks in complete sentences because of the dedicated Tilden staff. The District needs to be more involved with the parents to properly place their children.

Maria Isaac, parent, said Tilden staff works well together and they have a personal interest in her child. From the parent perspective, the issue is more than availability of bathrooms on the site. It is the human factor that is not being taken into consideration in the move.

Brenna Young, parent, said her son feels safe and comfortable at the site. The staff all know her son and he is making good progress.

Director Hodge said this process has to slow down. We talk about meaningful parent engagement and authentic engagement. We need to look at these things when we talk about culture of a school and about the environment. We should be determining what will save us down the road. She would like to see a cost analysis from our Facilities Department. Why is there a terrain problem? This is not something we can figure out. We need to take a creative look at this space. Is there a way to make it green? We are surrounded by four freeways and the air quality is bad. She understands what the speakers are saying about children being sick. We need to slow down and we need to think before we act.

Director Dobbins said the Tilden issue will be presented to the Facilities Committee tomorrow and to the full Board on March 11. We have to keep in mind that Tilden serves PreK to Grade 3 and there is no room for growth at this site.

Sharon Casanares, NEXO, said that some students at Tilden have already been moved to other sites. We are not questioning the integrity of teachers at Tilden. Our main concern is student safety. There are families currently at Tilden who are receiving a quality education. Tilden is not the only school that children can receive a good education. The more dedicated the program, the more we are able to prepare our students for their adult years.

Director Dobbins said there is the additional factor that the District may not be able to afford the \$750,000.

Superintendent Mayor thanked everyone who is here tonight. They are very impassioned about their school and about the quality of education for their children. The District is concerned about that, too. We should be talking about having a continuum of services to meet the needs of our children.

Chairperson Dobbins reminded everyone this item is being presented to the Facilities Committee tomorrow and to the full Board on March 11. It will also come back to this committee for a second reading at the next committee meeting on March 2.

Director Hodge reitereated her request for cost information on the facility issues at Tilden. **Discussed**

Kim Shipp asked about District efforts to address students who are not achieving at the high school level? Many students need help in CST, CAHSEE, and high school credits. She said funding can be redirected for Saturday School to help students who are Below and Far Below Basic. Brad Stam said there are high schools that offer Saturday School. He said an analysis about the effectiveness of the Saturday School can be brought back for the next committee meeting.
