G. Chief Academic Officer's Report

Brad Stam, Chief Academic Officer, said he had no formal report to make this evening.

Director Hodge asked for the following information on class sizes. It would be interesting to look at actual cost inside of schools. There are some schools that overspend their allocation and to look at schools that had gains and those that did not have gains. Chairperson Yee said committee members are requesting variables such as Free and Reduced Lunch, number of staff, amount allocated to each school and after school programs. Director Hodge said this is pushing ourselves away from just relying on test results. What else are we providing in our District for our students to hit that one particular benchmark that we all care about? It could be after school programming or that schools are staying within their budget. If it is about music that is showing up in the schools that students are doing well academically, then there is a connection there and we want to pay attention. Chairperson Yee said we had a conversation about a work session on Portfolio Management. Is there anything we do that enhances some schools and disadvantages other schools? What would be an assets map of effective schools? Mr. Stam said every school is slightly different. If we wanted to do an analysis across schools, that will take time if it were to be validated. The primary factor, 50%, is in the classroom; 10% is class size; 40% is the quality of instruction. We have wrap-around supporting complementary learning supporting services. We could come back in October to do a case study of a couple schools to find out what did those schools do to get the dramatic gains. How many case studies would the committee be interested in? After the presentation about a successful school, Director Hodge said she might have questions as to the number of SSO's and did the school have a PTA on site. Was there an after-school program? Has the school site team been together for 20 years? She would prefer to hear about 3-5 schools that Mr. Stam feels are rock stars. She would prefer more detail as to why the school is a rock star. Chairperson Yee asked how do we assign scores at a school? API rankings might be considered. He had a school-by-school budget sheet that came out last year. Director Hodge said she would like to select 3 or 4 schools after getting the rock star data, then she could dig a bit deeper. Chairperson Yee said if a school is performing well, the likelihood of it having a lot of SSOs would probably be less. Mr. Stam mentioned the Cambridge School Quality Reviews and staff can do correlative analyses between how they were scored and the API results. They have a detailed rubric which they used. They reviewed all of our Red schools.

The API scores range from 200 to 1000 for both schools and school districts based on State STAR testing. It measures academic performance and growth. There are APIs for subgroups as well. The API target is 800. Chairperson Yee asked about the number of schools who have hit the 800 target. Mr. Stam said he would get the information to the full Board.

Mr. Stam said the AYP threshold for this past year was at 45% for ELA. It is going up to 56% for 2010-11 and to 100% by 2013-14. For AYP we are not meeting AYP for African American, Latino, Pacific Islander, English Learner, or Students with Disabilities subgroups which is reflective of the achievement gap. A similar situation exists for Mathematics. We are still lagging behind with our African American, Latino, Pacific Islander, and Students with Disabilities subgroups. English Learners did make AYP this year in Mathematics.

Mr. Stam reviewed slides 12, 13, 14 on the District Accountability framework which is our Tiered Accountability and Support System. This past year, the tiering system relied heavily on a school's Program Improvement status. If a school had no Program Improvement status, it started in the GREEN. If a school were Program Improvement Year 0, 1, 2, they started in YELLOW; Program Improvement Year 3 in the ORANGE; and Program Improvement Year 4 and 5 in the RED. Schools received scores for their value add-in moving students more than one year's growth. Mr. Stam said the challenge under Program Improvement with the AYP metric going up ten percent a year is that it makes it unreachable for schools that are in Program Improvement to get out of Program Improvement. We are proposing for this coming year to have initial starting color of a school based upon their API score. We believe the API aligns the tiering to our State Accountability system.

Director Hodge asked about the stakeholders who helped him make the move here. Mr. Stam said he had conversations with principals, teachers, parents and community members. There was overwhelming frustration with getting out of Program Improvement once a school gets into it. Chairperson Yee said he has asked staff to present Board with a list of how the schools would be tiered under the old system and how they would be tiered under the new system. Director Hodge said the new system is an acknowledgement and creates an environment that is more fair and people are going to feel connected to their work.

Mr. Stam reviewed PowerPoint Information on the 2008-2009 Case Study for Allendale Elementary School. Under the old system they moved up to two tiers to YELLOW because they received credit for the growth in the gap. Allendale's API was at 741 at the beginning of last year so they would start in the YELLOW band. Mr. Stam said there are not too

many elementary schools below the YELLOW range still getting into the BLUE.

Chairperson Yee asked if staff could add the one-year growth to the slide information. It will help to dramatize the growth information.

Mr. Stam reviewed the Slide information for 2008-09 Case Study for Sequoia Elementary School. It is GREEN because it has no Program Improvement status and it is moving kids, but it has a large stagnate gap. In our current system, the school would stay GREEN. In the new system they would start at YELLOW, because while the school does not have Program Improvement, they are not over 800. They have the growth and they have the gap, but they would stay a YELLOW.

Chairperson Yee spoke of the charge to look at the Results Policy piece and to work on the Operational Expectations (OE). We are going to look at some of the Results policies and Mr. Stam will be presenting it in the near future for the Committee's consideration. We looked at three goals: academic achievement, student responsibility, and readiness for adult life. We wanted to propose the purposes of the evaluation three things to look at in terms of the academic achievement.

Brad Stam, Chief Academic Officer, said we had identified an English Language Arts measure for elementary and a math measure for middle school. We proposed using fifth grade for ELA. Our current achievement is either 44 percent or 45 percent of students who are Proficient and Advanced. The State CDE Report lists it as 45%. He and Chairperson Yee discussed the idea of a three-year target that can be averaged into annual growth. The goal would be that there would be a 25% increase over three years for 8.33% annual growth resulting in a 70% Proficient three years from now on the CST for fifth grade language arts. The first year goal is 8%. Director Hodge spoke of the Board's rubric: Satisfactory is 25% over three years which means 8% in the first year; Outstanding is 10% in the first year which get us up to 55%. The category Needs Improvement is anything moving back. Mr. Stam said the District has been making less than 8% growth in the fifth grade. Chairperson Yee said even though our Results Policy says reading by third grade, we felt an exit goal of the fifth grade is more powerful. It reflects more the cumulative effect of the reading program and it mitigates the English Learner problem early on in the students' grades. Regarding the goal for sixth grade math, Mr. Stam said we are currently at 34% Proficient and Advanced. The proposal would be a three-year target of 60% or a target of 26% increase over three years. That is slightly more than an 8.5% annual growth. The stretch target would be 66% or two-thirds of students and that would constitute Outstanding. Chairperson Yee said the reason we picked sixth grade was there was a

problem with the seventh and eighth grade algebra testing in algebra that students transition to. Since we want Algebra by ninth grade, most of the teachers will say the students having adequate pre-algebra preparation is key to them being successful when we go to algebra for all. We looked at the eighth grade goal, but the problem was the algebra. We are not ready for the algebra for all yet. Director Hodge asked if there is an adjustment that needs to be made for a student going into middle school? Chairperson Yee said the challenge at seventh grade is that half of the students will have been taking algebra. All students will be taking algebra in eighth grade, but many of the students are taking algebra in the seventh grade this year. When we do the testing in the seventh grade for math, the testing gets complicated by having some students taking general math and some students taking algebra. Mr. Stam said the math performance in 7th and 8th grade is equivalent. We have 35% 7th grade and 34% 8th grade. We had 7 percent growth in both grade levels. Chairperson Yee said he was encouraged if we could see a big bump because of Si Swun situation. It will not show up in seventh grade until next year. Mr. Stam said Swun Math for this coming year is in sixth and seventh grade, not in eighth grade. We are engaging in full implementation at sixth and seventh grade this year. We still saw the bump in seventh grade because of our emphasis on Professional Learning Communities and the math teachers were talking and working together and our Pacing Guides and Assessments were considerably improved last year over the previous year. Chairperson Yee suggested when this is presented to the full Board, to think about the sixth to the seventh grade issue around the Math.

Mr. Stam said there are two different measures for high school. One is CAHSEE Proficiency. It is 350 points to pass and 380 points to be Proficient. This is what the AYP is measured by. Our current performance is only that 25% of our students are Proficient on CAHSEE. A three-year target would be 40% representing 15% increase which is 5% annual growth. The second metric is CAHSEE tenth grade passage. These are students who are passing the CAHSEE in their first attempt in both sections. It is currently 54%. The three-year target would be 75% or 21% growth for a 7% annual growth. We did not set a Stretch goal for that.

Director Hodge noted the need for a marketing piece regarding the importance of CAHSEE, graduation, and CST goals. Chairperson Yee said one of our challenges is that we had 15 items in OE-11. He reorganized them into a different framework. He is proposing starting with "The Superintendent shall maintain a rigorous program of instruction that offers challenging and relevant opportunities for all students to achieve at levels defined in the board's Results policies. The Superintendent of Schools will: Align curriculum with academic standards that meet or exceed State and/or Nationally recognized standards and select instructional materials that have advanced the achievement of the board's Results Policies and that have achieved continuity, integration and articulation of the curriculum by the course of program. Chairperson Yee said it is about the standards and the curriculum. All of the Expectations and the subnumbers that had to do with standards and curriculum were lumped in there.

Chairperson Yee said the second item was to ensure that as instructional practice is based on a comprehensive and objective review of effective practices research. That is about all kinds of culturally responsive curriculum, meeting interactive instruction and all that we have done with Cambridge.

Chairperson Yee said the third area is effectively measuring each student's progress

toward achieving or exceeding the standards, including many things such as learning styles, needs of students, and individual talents development and interest in more specialized areas. That is lumping several of the others together. And, finally, ensuring that all instructional programs, including both content and practice are regularly evaluated and modified as necessary to assure their continuing effectiveness. The item (#5) Appropriately involve parents in the setting of instructional goals for their children; and (#13) Ensure appropriate input from students, parents, teachers, administrators and other staff members involved in the instructional program as textbooks are reviewed and selected. The rest are very minor. Director Hodge suggested adding #5 in the new number 2 lumped category. It is important for the Superintendent to have some eye on the Family and Community Office and that is one way we can judge whether he has a viable office running there. Mr. Stam urged to have #5 placed in the new #3 in that family members would know about specific needs and styles of the students and to support opportunities for students to develop talents and interests and to ensure we are measuring every student's progress. The new #2 could be focused on the Board holding staff accountable for ensuring that we are researching and evaluating the impact of each of our instructional programs. Director Hodge said #2 does stand very much by itself. She can live with #3 and #5 being a part of the #3. Effective measurement of each student's progress toward achieving or exceeding the standards appropriately involving parents, and ensuring that instructional program includes opportunities and insuring instructional program address the different learning styles, etc. She said #4, #5, #6, and #7 is a group; and #9 is by itself; and #2 and #12 are a group. Director Hodge said she would be taking this to the Safety Committee.

Chairperson Yee talked of the evaluation rubric for this Operational Expectation. He and Mr. Stam spoke of the emphasis on Professional Learning Communities, especially in the ninth grade houses because of the heavy investment and as a commitment to reducing drop out, truancy, and tardiness. Mr. Stam said beginning with the freshman class of 2011, all students must meet the UC/CSU course requirements in order to graduate from the District. We have convened a college and career planning council that is the Superintendent's committee that the Board charged the panel in its resolution. The council is building off of the work of the last two years of the College and Career Readiness Committee and has been streaming a course catalog to improve counseling services for students and to rethink the conditions for student success in high school. One of the tangible consequences of that effort has been the reorganization of the ninth grades at our three large comprehensive high schools into small learning communities. We have had an unacceptable high ninth grade drop-out rate and overall drop-out rate and we need to increase motivation, student engagement in the classroom, quality of instruction so that students once they get to high schools, stay in high school.

One of the things the committee has looked at is barriers to success that exist in many of our high schools. One of the key issues involves credit accrual. The smaller learning community model is that every ninth grader is known well and there are house leaders who are responsible for organizing their colleagues in the houses which have 6-10 teachers to take responsibility for a group of students and be a mentor to the students and to track their attendance and grades and classes; and if there is an issue early on, ensure there are interventions and support for the students. Another strategy involves the increase in number of ninth grade students who have mentors. We are piloting an on-track credit accrual so that students can master a specific set of standards and get the credit awarded. They would only have to work on the standards that they have not mastered. There was a

pilot last year at Oakland High School with two Algebra teachers. Their attendance was better, student motivation was higher and GPA was higher. Data regarding CST is not yet available.

Mr. Stam said the last one is ninth grade suspensions. Typically, suspensions can be a manifestation of students not being engaged or not being in class. That is a subset of what we are looking at and is more broad as part of the College and Career Readiness Plan. Ninth grade needs to be a focus for high school in terms of leading to tenth grade CAHSEE success and to focus on the leading indicators as to whether students are going to be successful in high school and stay in high school. Chairperson Yee stated this takes the OE and integrates it into a focus on something that is going to be new about this year which is the ninth grade houses. The ninth grade houses are going to be at Oakland Technical High School, Oakland High School, and Skyline High School. Director Hodge said at the high school level, we are going to measure CAHSEE Proficiency and ninth grade Houses.

Chairperson Yee said the fourth item has to do with our OE-11. The OE-11 was in four sections and we tried to figure out some kind of objective standard to measure whether or not he was successful in his instructional leadership. Rather than reiterating the testing data, we thought if Mr. Stam was doing full press on the ninth grade houses in the 3 major high schools, could we take a look at evaluating the success of that implementation in improving the students quality overall. This is about how they are doing in the classroom. We tried to figure out a way to integrate everything together. What we came up with has 3-4 different elements to it. Mr. Stam said it is part of the College and Career Readiness Plan which are areas we already are looking at as part of the score card for the high schools. It is integrated. He said tying the Superintendent's evaluation to particular strategies that adults may be using in the classroom may create challenges around the motivation for supporting teachers to use the strategies as opposed to evaluating on results. There are a variety of ways to get to the goal. Different schools can experiment with different configurations. The proof is in the student results, as opposed to adult practice goals.

Chairperson Yee said this one is complicated because we are trying to find a rubric or measure. This should be the lead-off discussion. When talking about instructional priorities, we need to ensure that we invest in those instructional priorities and this is one way of shaping that discussion. We do not have the money--we have the morale imperative.

A motion was made by Jumoke Hinton Hodge, seconded by Gary Yee, that this matter be Recommended Favorably. The motion carried by the following vote:
