Jeannie Johnson, College and Career Readiness, stated we have received the Lean to Learning grant from ConnectEd. An implementation plan was developed last year to spend the grant. The plan was developed with a broad range of stakeholders and includes A-G implementation and Linked Learning. The major activity for this year is getting five of our academies certified as certified pathways. We have approximately \$525,000 to spend this year. We are proposing to enter a contract with Oakland Schools Foundation in order to get a lot of this work done. We modeled this after the Pasadena Unified School District which uses its school foundation for similar work. Some of the work relates to A-G implementation and some of the work is intermediary services. There are people to assist us in meeting with businesses to place students into internships and help businesses know how to access our academies and schools.

Director Yee stated he would like some type of affirmation that this work cannot be done in house and that it needs to be outsourced. He appreciates the fact that this is a local vendor and he has a lot of respect for the vendor. As we enter into contracts going forward, he would suggest a process which states, especially for large contracts, that the work cannot be done in house or with our staff on extended contract. There are five high schools that are involved in this. Does the Oakland School Foundation intend to spend some portion of the funds on extended contracts or existing staff?

Chairperson Hodge said the Board brings this to staff regularly. Is there a need for a policy or clarity around discussion?

Ms. Johnson stated we are hiring three individuals in house. We began creating the positions last spring and expect to hire the individuals in November. Much of the remainder of the grant is paying for salaries of District employees and teacher stipends. A huge piece is professional development. We do not have anyone with the expertise within the District, especially the type of Business-to-School intermediary high level work that has to be performed. Because this is a two-year grant, we would hire the person temporarily for one year.

Director London stated it would be helpful to put up front the dollar amount of the contract, the requirements for spending, and details of the budget.

Ms. Johnson said the Linked Learning contract is for \$1.2 million dollars over a two-year contract.

Director London said she does not know if we received a formal presentation at a Board Meeting. The Board did not receive a report with details on the grant award for Linked Learning. She asked staff for a report with details about the grant and how we anticipate rolling the grant out.

Maria Santos, Deputy Superintendent, Instruction, Leadership, and Equity in Action, said it comes up where we are looking at whether we have the internal capacity for a body of work. We are looking to significantly increase and accelerate this work. Our contract with a vendor that has the expertise helps us to expedite the work. She said we can hold a discussion to present contracts in a context that is easily understood, particularly for these types of contracts where there is a time frame to accelerate the process, She is also carefully reviewing contracts for the types of services we are seeking externally.

Director London said it would be helpful to receive information on the entire grant's purposes. She does not recall material about hiring three District personnel for the Linked Learning portion of the grant.

Director London made a motion that we adopt Item 10-2500 and that, as it is brought forward to the full Board, that there be a description of the grant and how the contract fits into the grant that is attached to it that is included in the materials for public review when it comes to the Board next week.

Secretary Rakestraw stated the Committee can either Recommend Favorably in Committee or Forward Without Recommendation to the Board. He did not hear either of those recommendations in the motion.

Director London's motion died for lack of a second.

Chairperson Hodge made a motion to adopt Item 10-2500 based on the report of staff be carried out.

Director London said she would like to support the item, but with more context than it currently contains.

Ingrid Roberson, Executive Director, Research Assessment and Data, said this is a continued discussion of the presentation we did in September. We now have the added API information. She will be showing in motion charts our performance as a school district on the Academic Performance Index. Every school has been added, as well as information on the District and the State of California.

Ms. Roberson stated we have been the most improved urban district in the State for the last five years. We have increased by another 26 points this year and we are at 719 while the State is at 767.

Ms. Roberson stated Board Members had asked staff to disaggregate the data and we have added the API data by different subgroups While we have made significant gains as a school district, we still have an achievement gap. She displayed motion charts on the API for White students, as compared to African American students. For White students, we have an API of 914, as compared to 645 for African American students. She displayed State performance for African Americanand White students across the State of California. While the District has been catching up to the State at 719, we outperform the State in terms of White students at 838. For Oakland, we are at 914.

Ms. Roberson showed the performance of all of our different groups, including English Learner, Latino, Socially Economically Disadvantaged, and White students. The performance clusters were displayed for the District's African American, Latino, and Socially Economically Disadvantaged students, as compared Asian students, (Chinese, Japanese, Korean) and as well as compared to White students.

Chairperson Hodge recalled she had asked staff to disaggregate the information for the Asian population.

Ms. Roberson stated this information is based on the State's API. This is how they report out that information. There is not an actual API disaggregated by Korean/Japanese students. For the CST, we were going to initially take that on for the large groups, then go into the finer alliterations.

In response to Director Yee, Maria Santos, Deputy Superintendent, Instruction, Leadership, and Equity in Action spoke of the importance of improvement for all the groups. We need to do some aggressive work to accelerate for groups with a significant gap and we need to invest in strategic interventions. We also need to pay attention to academic language and literacy development across the board for Latino, Asian, and African American students as one significant lever for improvement. We also need to invest in strategic literacies, building the capacity of students, especially in the upper elementary levels, middle and high school levels, to engage with texts that are more difficult and require critical thinking, inference and synthesis. We also need to work on accelerating in the area where students have performance gaps, areas that they are having difficulty in learning. We have started a focal student initiative this year to target students out of the sphere of success for interventions.

Director Yee asked if staff would consider setting API goals for the groups, irrespective of where the gap is, then identify the strategies and the impact to get to a certain API score.

Ms. Santos stated we could look at API targets. We currently are looking at double digit gains.

Director Yee stated he would rather talk about double digit gains or set an API target for each group in a certain period of time.

#### CALIFORNIA STANDARDS TEST

Ms. Roberson used motion graphs to show California Standards Test (CST) data for percent of fifth graders who are Proficient or Advanced in English Language Arts over time, comparing State information to District information. She stated while the District is closing in on the performance as compared to the State of California, our African American students now have a higher performance. She said, in terms of double digit gains, we need to have higher rates of change for our African American students, if we are going to make substantial progress and it is happening at the elementary level.

Ms. Roberson used motion graphs for Oakland middle school eighth grade students and all students, as compared to African American students and compared to the State of California eighth grade performance. The graph showed the State is at 54 percent for Proficient or Advanced and 40 percent for African American students. We do not see that happening for eighth graders for the District, nor in terms of African American students. At fifth grade, we see ourselves catching up to the State and having our African American students outperforming, as compared to the State by the end of fifth grade. We are not seeing that same thing in terms of our eighth grade performance.

Ms. Roberson used motion charts to show eleventh grade performance for CST for all students, African American students and State of California. For the State, it shows the performance at 43 percent on the CST, as compared to 26 percent for the District. For African American performance, the chart showed 28 percent for the State of California and 14 percent for the District meeting grade level standards in English Language Arts.

Director Yee said for 2009-10, the African American line flattens out at the high school level and it does not do that at the elementary or middle school levels. He would like staff to tell him what they feel are the reasons for the 2009-10 drop in scores for African Americans and similarly for the 2006-07 significant drop. Those are significant deviations from the trend lines.

Ms. Santos said as we look at the data, we are looking for root causes. Having these tools available helps us navigate the data in different ways.

Mr. Montes de Oca stated Oakland Parents Together, Go Public Schools, OCO, and EBAYC have all recently received fliers for this to present to their school communities in an attempt to get high attendance for November 1.

Director London said very few of those groups serve schools in her District.

Mr. Valenzuela reviewed the summary of each complaint. He noted an error on page 2 relating to the Skyline High School facilities condition complaint. The following sentence in the RESOLVED sentence should be amended to read: In the summer of 2011, a roof top air conditioning unit will be installed.

Director London asked about the age of the portable classroom at Skyline High School. She said it is probably an old classroom and a more appropriate solution would be to replace it with a newer unit. She said she is uncomfortable in accepting the report until she has more information about the options regarding the age of the portable classroom.

Mr. Valenzuela stated we generally do not replace, as part of a Williams Complaint, the whole portable. We have many portables throughout the District and it would be a huge cost to the District to replace every portable that is old. He will get information from the Facilities Department as to the age of the portable.
