




#### \$25K Grant Helps Elmhurst United Music Students Rock

On February 16, Elmhurst United Middle School held a special event in celebration of its upgraded music program. With help from Elevate Oakland, the **Guitar Center Music Foundation** granted Elmhurst \$25,000. It paid for upgraded and new instruments across all the spectrums, including drums, electric guitars, brass, and woodwinds. It also paid for a new practice room built inside the existing music room, allowing for additional and diverse practice.

#### **Champion Skyline High Girls Volleyball Team Honored**

## **Care Plan for Phase 1 Students: Opportunity Ticket and School Placements**

- Students attending schools that are being closed, merging onto a different site, or are part of a grade configuration change will receive the **Opportunity Ticket** enrollment priority.
  - This goes *above* neighborhood priority for up to 50% of open seats.
- Prefill applications with Welcoming Schools (school closest to student's home) first) + 3 other closest schools.
- Enrollment staff will call families to see if they would like to change their school choices or re-rank them.
- Additionally:
  - Outreach to new incoming families whose only choices are closing schools (21 families thus far)
  - Attendance boundaries for school closures will be redrawn, based on analysis and community input, by August 2022.









#### **Enrollment events for families**

- Information nights for each closing school. Welcoming school principals and staff will attend and share information about their school programs, and staff from Student Welcome Center will support families with their applications.
- Tours of Welcoming schools will be offered to families.
- Additional staff has been assigned to support the Enrollment Process at each school.





## **Special Education**

- A designated welcoming school has been selected for each Special Day Class (SDC)
  program continuum. Those schools were selected on the basis of students'
  neighborhoods, general education feeder patterns, and the percentage of students
  with disabilities across campuses.;
- Students will automatically be slated to move to the welcoming campus with their current program to ensure each child has a site assignment, and there are options for families who would prefer a different site assignment.
- Each program at a school slated for consolidation will have a dedicated member of the Special Education team. That team member will share the catalog of school sites with similar programs across each grade level band.
- Students in SDC programs at schools will be given priority over incoming students at other campuses that can implement each student's IEP.





#### Care Plan for Staff: Talent Team

- Staff at all impacted sites will receive personalized, 1:1 support from Talent
- The goal is to meet individually with all staff at impacted sites and to be available 3-5 times over the course of the spring semester on site for initial, ongoing and follow up support.
  - 1) **Support** staff in the close/merge process;
  - 2) **Connect** staff with needed resources and information; and
  - 3) **Retain** staff in the district to reduce vacancies overall.







## **Welcoming School Plans**

#### Three layers of investment at Welcoming Schools



Facilities improvement for a welcoming environment

- Playground, landscaping improvement
- Painting, signage



Site-based care plan and welcoming activities

- Support for families as they transition to new school sites
- Rituals and routines for thoughtful close out and entry to new school



Professional Development and relationship-building

- Focus on inclusive practices and accelerated learning
- Building strong teams and managing through change







## Welcoming Schools: Facilities Improvements



- Walkthrough of each Welcoming School for Phase 1 Schools will be completed by 2/25/2022;
- Operations Team evaluates planned investments:
  - Classroom and cafeteria to receive increased enrollment at school sites
  - Classroom technology and infrastructure assessment
  - Review of library and literacy investments at school site
  - Signage and communication tools for the community
  - Playground, play yard and outdoor learning area@ elementary schools
  - Quality of painting to build on school branding and identity









#### **Welcoming Schools: Welcoming Activities**



- Enrollment Activities promoting the qualities of the Welcoming School;
- On Site Welcoming School Tours;
- Connect incoming Families with existing Families from the Welcoming School;
- Increased Social Emotional Investments: peer counseling, extension of existing mental health supports.
- Increased Academic Investments: Reading and math acceleration staff for small group instruction, Special Education support, technology programs, STEM enhancements.
- Enrichment /Extracurricular Investments: music, visual and performing arts, additional sports and physical education opportunities.
- Family Engagement Investments: Additional staffing to help bridget families as they transition to a new school setting.





## **Welcoming Schools: Relationship Building**



- Listen to incoming Families;
- Staff learns from families about students that will join their campus;
- Staff builds upon their existing assets to enhance their ability to serve new families;
- Professional learning about program enhancement investments is provided to staff;
- Expanded professional learning opportunities for Instructional Leadership Teams, Coordination of Services Teams, and School Culture Teams, etc.

#### School-Based Vaccine Pop-Ups at OUSD Schools:








74.5% of eligible students\* are fully or partially vaccinated



## **Testing Program**

- OUSD COVID-19 Testing is successfully testing 6,000+ people every week
- OUSD Testing Positivity Rate has dropped to 2.8%
  - Pooled testing has resumed at elementary sites
- All sites either have access to weekly on-site rapid or pooled testing (K-12), or at-home test kits (ECE)
- County Positivity Rate has dropped to 5%
- Preparations are underway for at-home test kit distribution for spring break








## **Covid Testing Implementation Update**

- Weekly Pooled Testing Pilot launched at 39 elementary sites; focus on training and gathering consent at new sites.
- Regular Bi-Weekly Testing at Secondary.
- Successful at-home testing program was expanded to serve more schools for winter holiday.




#### **Positive Case Dashboard and Protocols**

- 1. Weekly count of COVID-19 cases on school campuses are updated daily for the *previous* week
- 2. Count of classrooms currently in full at-home quarantine are updated daily for the *current* week

#### Dashboard last updated on 2/14/2022 Dashboard is updated daily at 7am to include all reported cases with presumed positive dates occurring in the prior week (2/7/2022 to 2/13/2022). Cases for the current week of 2/14/2022 will not be reflected in the dashboard until the following Monday. Counts include cases reported for OUSD school-based staff and students who were physically present on school campuses during their infectious period for COVID-19. Data may be incomplete depending on when the case was reported/confirmed and when contact tracing was completed. The presumed positive date is the earlier of first symptom onset or positive test collection date. Pursuant to updated guidance from ACPHD and CDPH as of 01/10/2022, classroom at-home guarantines will no longer be initiated following multiple cases. Positive cases will continue to isolate, and prolonged close contacts will be provided access to testing at school sites. Highlight School






