Summary of COVID Spending/Planned Investments 2020-2024

PLANNED AMOUNT	DESCRIPTION
\$283.7M	COVID Funds Allocated to OUSD
- \$65M	Total Spent 2020-21SY
- \$73M	Total Spent 2021-22SY
-\$42M	Total Spent & Encumbered 2022-23SY as of October 2022
\$103M	COVID Funds Remaining as of October 2022
- \$48M	Planned for the remainder of the 2022-23SY
\$55M	Remaining at the end of the 2022-23SY







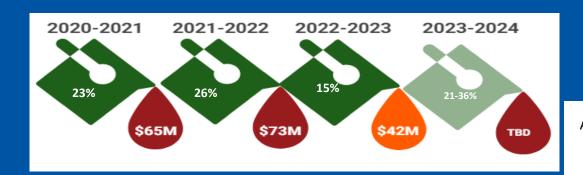


UPDATE: COVID Stimulus Spending Over Time

*22-23 spending includes encumbered totals



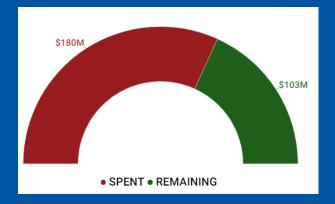




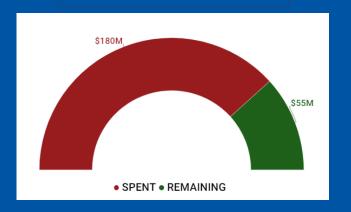


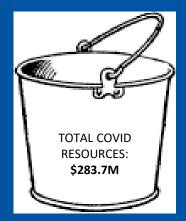
COVID SPENDING UPDATE

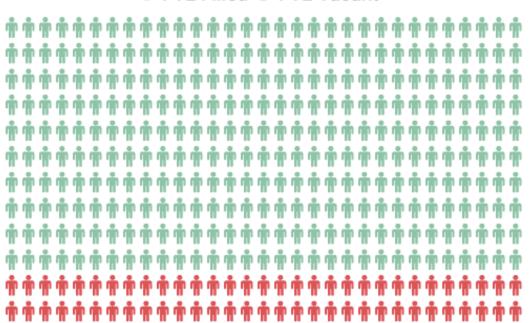




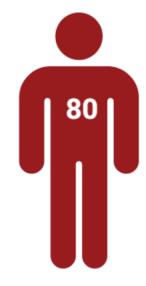
