Background The Oakland Unified School District is implementing an existing

Comprehensive Coordinated Early Intervening Services (CCEIS) Plan. When OUSD received COVID resources, 15% of those funds were to be set aside for the CCEIS Plan. The original 2021 CCEIS Plan budget totaled \$1,316,975.00. The amended CCEIS Plan with the additional 15% set aside

of COVID Funds now totals \$1,605,928.00, an increase of \$288,953.00.

Discussion The 2021 CCEIS Plan is currently being implemented. There are current

strategies that are supporting teachers with classroom management. This strategy is led by behavior specialists, who are trained professionals that are working with teachers to support them with implementing positive behavior strategies to benefit the management of the class. The

recommended investment is to increase the number of behavior specialists by 4.0 FTE. This is the recommended investment because there has been a positive decrease in referrals and suspensions at the targeted schools in which the behavior specialists are working.

Fiscal Impact

The LEA must reserve 15 percent of its 611 and 619 IDEA grant funds to address factors contributing to the significant disproportionality (See 34 CFR sections 300.646(c) and (d).) For Oakland Unified School District, the amount of funds that have been set-aside is \$1,316,975.00. COVID Funds were received in OUSD and are subject to the same 15% set aside, resulting in an increase by \$288,953.00, for a total of \$1,605,928.00.
