# **ACTION REQUESTED**

Ratification by the Board of Education of President of Board's reappointment of Patricia Lee (2<sup>nd</sup> Term), Harold Lowe (3<sup>rd</sup> Term), and Stephanie Hawke (2<sup>nd</sup> Term) to the Measure G Parcel Tax Independent Citizens Oversight Committee, for a term effective February 1, 2023 through January 31, 2025, respectively.

## **BACKGROUND/DISCUSSION**

The duties of the Measure G Committee, as defined by Board Bylaw 9131, is to inform the public concerning the expenditure of parcel tax revenues and to review and report annually on the proper expenditure of taxpayers' money generated by the 2009 Measure G parcel tax.

The Measure G Committee is composed of seven members, with staggered terms, appointed pursuant to membership criteria established by Board Bylaw 9131, with an individual's terms of appointment limited to a maximum of three two-year consecutive terms or the fulfillment of unexpired terms thereof.

Lee, Lowe and Hawke have satisfactorily served their prior term(s). Confirmation of the reappointments will leave one 1/7 vacancy on the Committee, for which recruitment is ongoing.

## RECOMMENDATION

I, pursuant to Board Bylaw 9131, hereby reappoint Patricia Lee, Harold Lowe and Stephanie Hawke, each, as a member of Measure G Committee, for a term effective February 1, 2023 through January 31, 2025. I ask confirmation by the Board of each reappointment.
