**Subj: Payment of Measure H Election Costs – Alameda County Registrar of Voters, Consolidated Printers, Inc., and Chinese Journal, LLC**

**ACTION REQUESTED**

Approval by Board of Education of payment of Measure "H" - 2022 Oakland Unified School District College and Career Readiness for All Act - November 8, 2022 General Election Costs - of \$900,823.13, as delineated.

**BACKGROUND/DISCUSSION**

The Board of Education on June 22, 2022, by adoption of Resolution No. No. 2122-0088 – Called a Parcel Tax Election and Authored Necessary Actions In Connection Therewith, in the fixed amount of \$120-per parcel tax for each taxable parcel in the City of Oakland with low income and senior citizen exemptions, known as the **2022 OAKLAND UNIFIED SCHOOL DISTRICT COLLEGE AND CAREER READINESS FOR ALL ACT or Measure “H”** (designated by the Alameda County Registrar of Voters), for the November 8, 2022 General Election.

Specific sections, among others, of Resolution 2122-0088, requested the Alameda County Superintendent of Schools and the Alameda County Registrar of Voters to take all steps necessary to place the Measure before the voters of the District in accordance with law and specifications and to reprint the full text of the Measure H in the Voter Pamphlet to be distributed to the voters of the District in the consolidated state-wide General Election to be held on November 8, 2022, respectively.

Accordingly, the Alameda County Registrar Voters honored in full the foregoing request and has now rendered the Measure H Bill for the election costs for services performed by its Office and its Agent, i.e., Consolidated Printers, Inc., Berkeley, CA and Chinese Journal, LLC, San Francisco, CA.
