ACTION REQUESTED

Ratification by the Board of Education of President of the Board's appointment of Jerry Wolfe (1st Term) to the Measure G Parcel Tax Independent Citizens Oversight Committee (Measure G Committee), effective February 10, 2022, for a term ending January 31, 2024.

BACKGROUND/DISCUSSION

The duties of the Measure G Committee, as defined by Board Bylaw 9131, is to inform the public concerning the expenditure of parcel tax revenues and to review and report on the proper expenditure of taxpayers' money generated by the 2009 Measure G parcel tax.

The Measure G Committee is composed of seven members, with staggered terms, appointed pursuant to membership criteria established by Board Bylaw 9131, with an individual's terms of appointment limited to a maximum of three twoyear consecutive terms or the fulfillment of unexpired terms thereof. There are currently four vacancies on the Committee.

Mr. Wolfe is a retired administrator, principal, and teacher of the District. Wolfe is a Community member who does not currently have a child enrolled in the District, a criterion for appointment. Mr. Wolfe's application, redacted in part, is attached.

I, pursuant to Board Bylaw 9131, hereby appoint Jerry Wolfe, as a member of Measure G Committee, filling an unexpired term, effective February 10, 2022, ending January 31, 2024. I ask confirmation by the Board of his appointment.
