**Background**

# RESOLUTION OF THE BOARD OF EDUCATION OF THE OAKLAND UNIFIED SCHOOL DISTRICT

#### Resolution No. 2223-0032

#### **Including Family Voice in Collective Bargaining Agreements and Labor Negotiations**

WHEREAS, our students are in crisis: According to the most recent data of K-5 students in OUSD<sup>1</sup>, fewer than 3 in 10 Black and Brown kids (32%) are reading at or above grade level, and approximately 2 out of 10 Black and Brown kids (21%) are doing math at or above grade level;

**WHEREAS,** through meaningful family engagement, we envision a transformed school system that has directly confronted and actively addressed inequity and injustice so that every OUSD student can learn to read and do math well so that they can graduate and become a fully engaged member of our community;

**WHEREAS,** research has validated that parental involvement in public schools has been a key factor in producing measurable gains in student academic success, closing the achievement gap, reducing dropout rates, increasing graduation rates, promoting positive adolescent behavior, and furthering student's emotional development;

**WHEREAS,** the Oakland Unified School District ("District") has an obligation to promote the inclusion of family voice in determining the conditions under which students learn and exercises an abiding commitment to its Standards for Meaningful Family Engagement;

**WHEREAS,** the Collective Bargaining Agreement sets the terms and conditions of how, when and where our kids learn and has deep and widespread impact on our children's education;

**WHEREAS,** families of students in Oakland Unified historically have been offered very little visibility and information on the collective bargaining process and have not been afforded meaningful opportunities to voice their views on the conditions for teaching their children that are negotiated and agreed upon during negotiations;

**WHEREAS,** the Educational Employment Relations Act (EERA; Government Code section 3540 *et seq.*) provides for and establishes requirements for collective bargaining between public school employers and exclusive representatives of certificated and classified employees;

**WHEREAS,** the EERA obligates public school employers and exclusive representatives to present their initial negotiating proposals to the public and to provide an opportunity for public expression on such proposals;

**BE IT FURTHER RESOLVED**, the Board of Education is calling for meaningful opportunities for family voice in determining the conditions under which their children learn; and

**BE IT FURTHER RESOLVED**, the Board of Education of the Oakland Unified School District is committed to offering families meaningful ongoing opportunities for public expression on all labor agreement proposals, including but not limited to collective bargaining agreements, sideletter agreements and memoranda of understanding.
