Subject **APPROVAL OF AMENDMENT TO AGREEMENT ACCEPTING GRANT FUNDS IN THE AMOUNT OF \$325,000 DOLLARS FOR FISCAL YEAR 2013-14 FROM THE ROGERS FAMILY FOUNDATION FOR THE BLENDED LEARNING PILOT PROGRAM**

Action Requested **APPROVAL OF ACCEPTANCE OF GRANT IN THE AMOUNT OF \$325,000 FOR FISCAL YEAR 2013-14 FROM THE ROGERS FAMILY FOUNDATION**

**Background** For the 2012-13 school year, Oakland Schools Foundation (OSF) received a grant in the amount of \$1,000,000 from the Rogers Family Foundation for the purpose of supporting the implementation of the "Blended Learning" computer based connected learning program which supports real time differentiation for individual students. During 2012-13, "Blended Learning" was piloted in four OUSD schools: Emcompass, Elmhurst Community Prep, Madison and Korematsu. This amendment continues support for the pilot by providing additional funds and adding two middle schools.

**Discussion** The purpose of this Amendment is to extend the term of the Agreement for the 2013-14 school year with the following modifications:

- 1) Edna Brewer Middle School and Bret Harte Middle School are added as participating pilot schools.
- 2) For the 2013-14 school year, OSF has received a grant from the Rogers Family Foundation in the amount of \$325,000 for the purpose supporting the implementation of the "Blended Learning" program in the pilot schools.
- 3) The District shall contribute \$125,000 for the 2013-14 fiscal year to be used for the purchase of student computer to support Blended Learning at the six District pilot schools.

**Recommendation** Acceptance by the Board of Education of the grant in the amount of \$1,000,000 from the Rogers Family Foundation for the fiscal year 2012-13.

During 2012-13, "Blended Learning" was piloted in four OUSD schools: Emcompass, Elmhurst Community Prep, Madison and Korematsu. The purpose of this Amendment is to extend the term of the Agreement for the 2013-14 school year with the following modifications:

- 1) Edna Brewer Middle School and Bret Harte Middle School are added as participating pilot schools.
- 2) For the 2013-14 school year, OSF has received a grant from the Rogers Family Foundation in the amount of \$325,000 for the purpose supporting the implementation of the "Blended Learning" program in the pilot schools.
- 3) The District shall contribute \$125,000 for the 2013-14 fiscal year to be used for the purchase of student computer to support Blended Learning at the six District pilot schools.

Except as expressly provided herein, the Agreement is unchanged.

This Amendment to the Agreement, together with the Agreement between the Parties constitutes the entire understanding and agreement between the Parties related to the Blended Learning pilot program. All understandings, agreements, covenants, representations and warranties, express or implied, oral or written between are contained and merged herein. No other agreements, covenants, representations or warranties, express or implied, oral or written, have been made by or between the Parties concerning the subject matter hereof. This is an integrated agreement. It may not be altered, modified or otherwise changed in any respect except in a writing signed by each party.






