#### **BACKGROUND/DISCUSSION**

Among the duties of the Audit Committee, defined by Board Bylaw 9131, but not limited to, are review of the District's annual audit with the independent auditors, review with District's financial staff the internal auditing and financial controls of the District, recommendation to Board of the selection of independent auditors of the District and production of annual reports of findings and recommendations on Committee subject matter to the Board of Education. The Audit Committee is maintained at the recommendation of the Financial Crisis Management and Assistance Team as a best practice for highly functioning school districts.

The Committee is composed of five members, with staggered terms, appointed pursuant to membership criteria established by Board Bylaw 9131, with an individual's terms appointment limited to a maximum of three two-year consecutive terms.

There currently exists one vacancy on the Audit Committee with an unexpired term ending January 31, 2019.

My goal is to insure that individuals, particularly in key positions, have a clear focus on their purpose and know how to engage others to get at the most accurate picture of processes as they actually function. My experience has been that many critical process may be broken at multiple junctures, and an audit committee can seek to reveal such conditions by calling for detailed presentations and asking critical questions. I believe that a public organization will not achieve "efficiencies" without finding ways to promote a real-world appraisal of its processes and to suggest specific solutions that can actually be implemented.

I have served on the board of directors of many nonprofit organizations over the years. Currently I am a member of the Martin Luther King, Jr Freedom Center board, the Oakland Community Fund, and Congresswoman Barbara Lee's Finance Committee. In the mayor's office I created the Mayor's Oakland Business Leadership Form, and a range of lower income youth summer camps such as the Summer Performing Arts Day camp and a reading camp called Camp Read-a-lot. In my neighborhood I launched an annual Cottage Industry Artisan Show, and a new community group, the Glenview Community Coalition, to host events around topics such as Racial Profiling, and lawn conversion for drought resistant plants. I have facilitate dozens of dialogue sessions with public, private, education, and nonprofit organizations during the past several decades.
