BACKGROUND: As per Education Code Section 35186, the Superintendent or designee shall report summarized data on the nature and resolution of all Williams Uniform Complaints on a quarterly basis to the Governing Board and the County Superintendent of Schools. The report shall include the number of complaints by general subject area with the number of resolved and unresolved complaints.

April 2025	Greenleaf Elementary School (88) [87 Anonymous complaints]	Facilities Condition - Music Teacher complained that the Music Room in the basement does not have soundproofing panels which were above the sound decibel level for students. They also complained that the noise level for the music class held on the auditorium stage was too loud during lunch.	Yes. Risk Management hired a consultant to check the noise decibel level which was determined to be above the standard in the basement music classroom. The Buildings and Grounds Department conducted several site visits and installed soundproof panels on the ceiling of the music classroom in the basement. However, they are reviewing the noise levels concerns about the stage as it is not designed for use as an enclosed classroom.	Resolved
April 2025	Greenleaf Elementary School (88) [87 Anonymous complaints]	Facilities Condition - Music Teacher complained that there was a water leak because the carpet on the floor was wet in the music room.	Yes. Risk Management hired a consultant to check for mold which was unsubstantiated. Buildings & Grounds conducted multiple site visits as repairs to the Music Room in the basement were completed a few years ago. Buildings & Grounds determined that the water pump transferring excess water from the basement to the street was backed-up and was repaired.	Resolved
