ACTION REQUESTED

Adoption by Board of Education of Resolution No. 1415-0128 - Repealing Establishment of and Appointment of Members – 7-11 Committee.

BACKGROUND

The Board in recent months, before November 19, 2014, by Resolution Nos. 1314-1108; 1314-1108A; 1314-1108B, as provided in California Education Code Section 17389, established and appointed members of a District 7-11 Committee to advise the Board on the reuse, repurposing and disposition of school buildings and vacant sites not needed for school purposes.

The Board enacted an Updated 2015-2020 Five Year Strategic Plan “Pathway to Excellence” on November 19, 2014, which provisions now may require the Board to first make other major District strategic policy decisions prior to the need for the establishment of a 7-11 Committee, if the latter at all.


