- RE: Recommended Next Steps for Parcel Tax Exemptions

As you know, the Measure N Parcel Tax appeared on Oakland property tax bills a few weeks ago. This is the first year for Measure N, and this is the first year that the District's parcel tax has an exemption for Senior Citizen homeowners. Both Measure N and our other parcel tax, Measure G, have an exemption for low income homeowners. Apparently, many seniors and others who qualify for exemptions from OUSD's parcel taxes had not heard about the application process prior to the application deadline, which was June 30 (and was extended to July 15). At this stage in the tax collection process, we cannot exempt anyone from paying the tax, but we can reimburse them for the taxes they owe. (The reimbursement assumes they will pay their taxes as billed.)

To foster the continued support of the senior citizen community, the District has been asked to communicate the process for reimbursement and exemptions (for 2016-17) more broadly.

The fiscal, communications, IT and legal teams met today to review our options and recommend a plan of action going forward.

1. Send out a communication to all property owners in Oakland.

- The communication will include a letter from you in the spirit of thankfulness, thanking voters for Measure N, Measure G, and Measure J, and explaining how we are improving fiscal transparency and using those funds wisely to improve outcomes for students and improve the physical environments for learning.
- Communications will develop the letter in the next 2-5 days for your review.
- The backside of the letter will have information about how to apply for an exemption, including directions for getting applications in different languages (Spanish, Chinese, Vietnamese, Cambodian, Arabic) from the <u>www.ousd.org/parceltax</u> website, or calling the hotline.
- An application for exemption (in English) will be enclosed with the letter.
- IT has already prepared a file that will be used to create mailing labels from the database of property owners provided earlier in the year by the county. There are approximately 110,000 names/addresses in the database that covers all property owners, regardless of property type.
- We expect the letter can go out the first week in December.

2. Make sure the application is available in 5 languages.

- The application is already available in English, Spanish, Chinese, Cambodian and Vietnamese. These are available by request and have not yet been posted on the website, but we will do that as soon as we can.
- We will also get it translated to Arabic.
- The notice explaining the option to apply for a reimbursement is currently only available in English. That will be translated also, for posting to the website along with the applications.
- 3. The deadline to apply for a reimbursement will be April 15, 2016.

4. The reimbursement applies to both the Senior exemption for Measure N and the low income exemption for both Measure G and N.

5. The reimbursement is for this tax year only (2015-16).

6. A property owner must have turned 65 by June 30, 2015, to qualify for the Senior Exemption.

7. All property owners who receive an exemption this year will automatically receive a renewal application next year in plenty of time to submit before the exemption deadline.

8. We will meet again in January to plan the communications for the 2016-17 exemption process.

RE: Reimbursement for Senior Citizens for First Year of Measure N Parcel Tax

Dear Taxpayer,

I understand you are interested in the Senior Citizen Exemption from the Oakland Unified School District's Measure N Parcel Tax. In order to meet the County's deadline to complete the tax rolls for the 2015-16 tax, the District set June 30, 2015 as the deadline to apply for the senior exemption. However, because this is the first year of the Measure N parcel tax, the District has agreed to allow for late applications and reimbursement for qualified taxpayers. Please fill out the attached application and submit the application with the required documentation by mail or in person to the OUSD Fiscal Services Office at 1000 Broadway, Suite 450, Oakland, CA 94607, or by email to ousdparceltax@ousd.org.

In addition to the application form, please be sure to submit (1) a copy of your **2015-16** tax bill, and (2) proof of age, which can be a copy of your driver's license or DMV identification card, Medicare card, birth certificate, passport or other government issued ID.

If you qualify for the exemption, the District will process the reimbursement for the full \$120 Measure N parcel tax. In the meantime, <u>please pay your property taxes to the County as billed</u>.

Please allow at least 20 business days for us to process your application and mail the reimbursement check.

THE DEADLINE TO SUBMIT FOR REIMBURSEMENT FOR 2015-16 IS APRIL 15, 2016.

Next year, a 2016-17 application form will automatically be mailed to everyone who qualified for an exemption in 2015-16. Information about the parcel tax program is available on our website: www.ousd.org/parceltax. You can also call the Parcel Tax Help Desk at 510-879-8884.
