**WHEREAS** – Alison Streich joined OUSD in 1993, serving first as a Kindergarten and Special Education teacher before joining the OUSD music faculty in 2004, and

**WHEREAS** – Alison was a member of the original MILE (Music Integrated Learning Environment) program, creating an innovative collaboration process between classroom teachers/students and music teachers, which culminated in an original musical, "The New Kid and The Bully" performed at Glenview Elementary and,

**WHEREAS** - Alison was key in returning instrumental music programs to West Oakland schools, through the formation and nurturance of active instrumental music education programs in Lafayette and Martin Luther King Elementary schools that laid the groundwork for Middle School Orchestra classes, and

**WHEREAS** - Alison conceived and created the Oakland Spirit Orchestra, a 30-piece band drawn from West Oakland Elementary, middle and high schools, whose mission is to "uplift the spirits of the world through music and kindness" and which she describes has her dream come true;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Education and the Superintendent of the Oakland Unified School District salute Alison Streich for stellar service to the students and city of Oakland and honor her as one of the District's 2014-2015 Teachers of the Year.


