Subject Approval of Quitclaim Deed - 1700 Market Street

Action Requested and Recommendation Approval by the Board of Education of Quitclaim Deed for 1700 Market Street, Oakland, CA

Background and Discussion The title report relating to the District's property at 1700 Market Street reflects that title to certain parcels that comprise the school campus are held by The Board of Education of the City of Oakland a predecessor name for the Oakland Unified School District. Because The Board of Education of the City of Oakland is no longer a valid legal entity this Quitclaim Deed transfers all interests in the property to Oakland Unified School District as the successor entity. In short, the Quitclaim Deed clears the District's title in the real property.


