Orientation for New Members including review of the Committee Bylaws and Committee Charge pursuant to Resolution No. 0607-0031 of the State Administrator (Board) of the Oakland Unified School District adopted August 31, 2006.

Meredith Brown, Special Counsel for the Measure B Committee, reviewed the Committee By-laws and Committee Charge pursuant to Resolution No. 0607-0031 adopted in 2006. The voters of Oakland authorized School Facilities Bond Measure B. As required by law, the District established and appointed an Independent Citizens School Facilities Bond Oversight Committee. The purpose of the Committee is to monitor and report to the public regarding the expenditure of school bond funds.

The Committee is composed of 11 members and the term of office is 2 years. Vacancies currently exist due to excessive absences (three consecutive) at regularly scheduled meetings. Every active decision is made by a majority vote of the total membership. Meetings are conducted in accordance of the Brown Act. All site visits are noticed since

gathering of a majority of members is considered a meeting under the Brown Act. Dr. Cooke encouraged members to visit sites. Committee Members can make a site visit as citizens.

The Committee Shall do the Following:

- 1. Inform the public concerning the expenditure of bond revenues.
- 2. Actively review and report on proper expenditure of taxpayers' money for school construction.
- 3. Ensure that the bond funds are expended in accordance with the language of the bond.

The Committee May do the Following:

- 1. Review copies of independent performance and fiscal audits pertaining to the District's bond program.
- 2. Inspect school facilities and grounds to ensure that bond funds are expended in accordance with the language of the bond.
- 3. Review deferred maintenance plans of the school district.
- 4. Review cost saving measures proposed by the school district.

Bond Language:

Measure B was passed with specific guidelines that restricted project expenditures to those included in a Bond Project List describing the specific projects that the District proposed to authorize with the proceeds of the bonds. The list of projects approved list of Measure B projects school facilities bonds are listed in the Facilities Master Plan adopted by the State Administrator on February 8, 2006. The Bond Project list includes those projects listed in the Facilities Master Plan, which is on file with the Secretary and Executive Assistant to the State Administrator and the Board of Education. The projects include:

- Classroom renovation and repair;
- Auditorium and multipurpose room renovation and construction;
- Playground and gymnasium rehabilitation; and
- Upgrades as well as construction of missing educational facilities such as libraries, media centers, science labs, computer labs, art and music classrooms and vocational shops and laboratories.

The Bond Project Lists also included Pre-School/Early Childhood Development Center Projects, matching funds for deferred maintenance projects and the repair, rehabilitation and modernization of existing student-based health care service facilities, as well as construction of new student-based health care service facilities.

08-0403 Report - Committee Facilities Site Visits

Report on Facilities site visits by Committee.

Dr. John Cooke, Jody London, Tadashi Nakadegawa, Director of Facilities, visited Madison Middle School, Cox Elementary, and Elmhurst Middle School.

Highlights of Madison included the work to be completed:

- Planned installation of exit corridor for emergency purposes to prevent vandals from entering;
- Closing the middle yard;

- Construction of medal pyramid preventing access to the roof;
- Plans to design and install community football field; and
- Convert unused shop to a community Health Center.

Highlights of Elmhurst included the work to be completed:

- Student cafeteria has been painted and dropped natural lighting installed;
- Energy efficient lighting installed;
- The library scheduled for upgrade with brighter energy efficient environment:
- Auditorium scheduled renovations;
- Hallways and restroom lighting will be upgraded and restrooms are scheduled to be upgraded with efficient toilets; and
- The gym is scheduled for upgrade and the restrooms upstairs will be upgraded.

Highlights of Cox included the work to be completed:

- Construction of a new building that will house the charter school currently leasing property from the District.

Jody London asked how the rental fees are determined and why were we making improvements for a charter school?

Timothy White stated Charter schools are District properties leased to the charter schools and any improvements made are to District property,

Another visit was made to Cole, Bunche, and Hoover Schools.

Highlights of Cole included the work to be completed: A planned health center to include a social worker and rotating dental screening.

Bunche houses Alternative Education Programs, Special Day Classes, and a County School. This site consists of all portable classrooms that are 40-50 years.

Hoover had extensive water damage on the floor of the stage and in classrooms; the kitchen area of the cafeteria is getting new flooring.

Processes are already in place for sites to put repairs on line and not wait for a large project to take place.

There was discussion regarding sub-committees. Parker Thomas said there was a conversation about established sub-committees. Dr. John Cooke said that sub-committees had been formed, but after looking at the Bylaws and the Brown Act, the Committee cannot go on site visits unless the visits are agendized. Edgar Rakestraw, Secretary and Executive Officer, Board of Education, stated after taking a second look at the Bylaws there is no authorization for the creation of sub-committees and the creation of past sub-committees was not proper. There is no discussion of sub-committees in the Education Code. The entire body is charged with oversight. Mr. Thomas said getting everyone on a site visit is difficult.

Mr. Thomas would like for the committee to take a more active role by selecting projects to

focus on and to direct staff. Mr. Rakestraw responded directing staff is not a function of the Measure B Committee. He said issues and concerns committee members may have can be brought to the attention of the Facilities Staff, the Board and the District.

Committee Members may ask staff questions in advance by email and staff will reply by email in advance of committee meetings. Questions should be given to the Chair prior to being given to staff.

Mr. Joseph Debro asked about the Project Labor Agreement and are we getting adequate local training for our youth? The current agreement has a goal of 50% local hiring and 50% local apprenticeship program. The Project Labor Agreement will be presented at a future committee meeting.
