Re: Amendment, President's Appointments for 2023 Term - Board Liaison - Measure G1 – Districtwide Teacher Retention and Middle School Improvement Act Oversight Commission (G1 Commission)

**ACTION REQUESTED**

Ratification by the Board of Education of the President of the Board’s appointment of Mike Hutchinson, succeeding Nick Resnick, as the Board liaison, to the Measure G1 - Districtwide Teacher Retention and Middle School Improvement Act Oversight Commission, for the remainder of the 2023 term.

**BACKGROUND/DISCUSSION**

Board Bylaws 9130 and 9131 vests the President of the Board with the authority to appoint members of committees of the Board, advisory and oversight committees and commission(s), and representatives of the District or Board to other entities, subject to the advice and consent of the Board.

President Mike Hutchinson nominated and the Board confirmed on January 25, 2025, pursuant to the aforementioned Bylaws, Board Member Nick Resnick, as the Board liaison - Measure G1 – Districtwide Teacher Retention and Middle School Improvement Act Oversight Commission for the 2023 Term. Board Member Resnick resigned from the Board on February 21, 2023, creating a Board liaison vacancy to the G1 Commission. I have nominated myself to fill the G1 Commission Board liaison vacancy for the remainder of the 2023 term.
