We held our most recent public meeting on January 15th. At that meeting, everyone:

- Learned what decisions the School Board made in December to address the OUSD budget deficit for School Year 2025-26 and beyond
- 2. Discussed their questions with Chief Business Officer Lisa Grant-Dawson and President Brouhard
- 3. Identified which of the decisions were most confusing and which caused the most far-reaching changes

These were the budget decisions that participants chose for in-depth discussion at the next PSAC on February 19th:

#2: "Eliminate management positions in Senior Leadership Team departments."

#28: "OUSD Safety Investments. Establish a funding methodology and practice for safety needs."

#24: "Review master schedules so that there is consistency and equity across schools."

#17: "Convert some 11-month and 12-month to 10-month (Community Schools Managers, Case Managers)..."

#9: "Increase Average Daily Attendance by 3%."

#11: "Eliminate Teachers on Special Assignment that are funded with on-going dollars except as required by contracts and Memorandums of Understanding"

#18: "Revise how Full-Time Equivalent [positions] and other allocations are assigned to schools. Develop a Quality Schools Model for assigning them.

At our February 19th, district leaders will discuss how these and other changes will look and feel through the example of four schools. They will pay special attention to the specific budget decisions that everyone identified at our January meeting.


