## Resolution of GOVERNING BOARD OF THE OAKLAND UNIFIED SCHOOL DISTRICT

Resolution No. 1112-0146

Amendment of Board Policy – Students – BP 5116 – School Attendance Boundaries – Effective July 1, 2012

WHEREAS, the Oakland Unified School District is creating a great public school system with high standards of teaching and learning for every student and high standards of service to our schools with a recommitment to our shared values of equity, achievement, and accountability; and

**WHEREAS**, a core strategy of Oakland Unified School District is the management of a portfolio of schools that will provide a diverse portfolio of high quality schools for students and families both within neighborhoods and district-wide; and

**WHEREAS**, the Board of 'Education on October 26, 2011 voted to close Lakeview Elementary School, Lazear Elementary School, Marshall Elementary School, Maxwell Park Elementary School, and Santa Fe Elementary School, effective June 30, 2012; and

WHEREAS, attendance area boundary changes are necessary to ensure that all residences in the attendance areas of those closing schools are provided an attendance area designation for enrollment purposes; and

WHEREAS, staff has contemplated enrollment data, geographic boundaries and logical street patterns, safety and transportation, density of school-age children, capacity of facilities, community identity and input, racial and ethnic balance, educational programs; and

WHEREAS, staff has developed preliminary boundary change scenarios, conducted public announcements re: boundary change process, community input, and public hearing dates; conducted community input meetings located in neighborhoods affected by proposed boundary changes; held a Board of Education Public Hearing re: proposed boundary changes on December 14, 2011, and developed final recommended attendance boundary changes; and

WHEREAS, staff recommendations include the adjustment of the following attendance areas effective July 1, 2012:

- 1. Allendale Elementary
- 2. Burckhalter Elementary
- 3. Cesar Chavez (International Community School, Think College Now)
- 4. Cleveland Elementary
- 5. Crocker Elementary

NOW, THEREFORE, BE IT RESOLVED THAT, upon the recommendation of the Superintendent of Schools, the Board hereby Amends Board Policy - Students – BP 5116 – School Attendance Boundaries, effective July 1, 2012, as stated herein: that the current Allendale Elementary, Burckhalter Elementary, Cesar Chavez (International Community School, Think College Now), Cleveland Elementary, Crocker Elementary, Emerson Elementary, Garfield Elementary, Grass Valley Elementary, Horace Mann Elementary, Howard Elementary, Jefferson Elementary (ASCEND, Global Family, Learning without Limits), Laurel Elementary, Lincoln Elementary, Peralta Elementary, Piedmont Elementary, Sankofa Academy School Attendance Boundaries are hereby expanded to incorporate the addresses as described by the included addresses and attendance area maps, attached hereto, incorporating the current Lakeview Elementary School, Lazear Elementary School, Marshall Elementary School, Maxwell Park Elementary School, and Santa Fe Elementary School Attendance Boundary areas, due to the closure of the later attendance area schools on June 30, 2012; and

**BE IT FURTHER RESOLVED** that effective January 11, 2012 pupils and parents residing within the current Lakeview Elementary School, Lazear Elementary School, Marshall Elementary School, Maxwell Park Elementary School, and Santa Fe Elementary School Attendance Boundary attendance areas shall be afforded the neighborhood priority for school choice, pursuant to the district's Open Enrollment policies, within the new attendance boundary for School Year 2012-13; and.



**BE IT FURTHER RESOLVED** that the Superintendent of Schools or his designee is authorized to take any and all action, save an action required of the Governing Board by law, regulation or Board Policy, to effectuate the foregoing.
