This Memorandum of Understanding ("MOU") is entered into between the United Administrators of Oakland Schools, ("UAOS") and the Oakland Unified School District (the "District") collectively referred to (as the "Parties"). Regarding unit members who volunteer for extended learning opportunities connected to new Early Childhood classes (PK and TK) on their campuses.

WHEREAS, the Parties are committed to working together to ensuring that Elementary School principals have the skills, training, resources, and support to ensure quality, developmentally appropriate early childhood educational experiences for all the 3 and 4 year olds on their campuses

WHEREAS, grant funding from Measure AA, Oakland Children's Initiative (OCI), and from the Alameda County EETD Grant has been awarded to the District;

THEREFORE, the Parties agree as follows:

- 1. Effective July 1, 2024 through June 30, 2027 UAOS members within the classification of Principal and Community School Managers who voluntarily participate in Extended Learning Opportunities provided by the Early Childhood Department beyond their contractual hours shall be compensated accordingly:
