WHEREAS, the State of California will defer or has deferred certain apportionments to California school districts in February, April, May and June; and

WHEREAS, the Board of Education of the Oakland Unified School District has determined that there may be insufficient cash in Fund 01 (General Fund) to meet the District's obligations based upon the ongoing deferred funding by the State; and

WHEREAS, Education Code Section 42603 permits the Governing Board of any school district to direct that monies held in any fund or account may be temporarily transferred to another fund or account of the district for payment of obligations and that such borrowed funds shall not be available for appropriation or be considered income, during the current fiscal year to repay the amount transferred; and

WHEREAS, amounts transferred shall be repaid either in the same fiscal year, or in the following fiscal year if the transfer takes place within the final 120 calendar days of a fiscal year,

NOW, THEREFORE, BE IT RESOLVED that the Governing Board of the Oakland Unified School District, in accordance with the provisions of Education Code Section 42603, hereby specifically authorizes for fiscal year 2012-13 the temporarily transfer up to \$25 million dollars from Fund 21 (Building Fund) to Fund 1 (General Fund);

BE IT FURTHER RESOLVED that said borrowed funds shall be and are hereby authorized to be repaid to Fund 21 from Fund 1 pursuant to the requirements of Education Code Section 42603.
