**Proposed Name - Elmhurst United Middle School - For The Merged Schools Of - Alliance Academy And Elmhurst College Preparatory School - Effective July 1, 2019**

**WHEREAS**, Oakland Unified School District (“District”) Board Policy (“BP”) 7310 authorizes the District, after a public hearing held by the Board at which members of the public will be given an opportunity to provide input, to rename a District school; and

**WHEREAS**, Alliance Academy (“Alliance”) is the current name of a middle school located at 1800 98<sup>th</sup> Avenue, Oakland CA 94603; and

**WHEREAS**, Elmhurst Community Prep (“Elmhurst”) is the current name of a middle school also located at 1800 98<sup>th</sup> Avenue, Oakland CA 94603; and

**WHEREAS**, the Board has previously approved the merger of Alliance and Elmhurst into one middle school effective on June 27<sup>rd</sup>, 2019 (District Resolution No. 1718-0229); and

**WHEREAS**, the District seeks to change the names of Alliance and Elmhurst to Elmhurst United Middle School effective on July 1, 2019; and

**WHEREAS**, the District’s Board has held a public hearing at which members of the public have been given an opportunity to provide input on the foregoing name changes; and

**WHEREAS**, under California law the District must submit a County-District-School (“CDS”) application, by and through the District’s designated CDS Coordinator, to the California Department of Education (“CDE”) to rename a school or schools and to update said school’s/schools’ CDS information;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of the District, as follows:

**Section 1. Recitals.** All of the above recitals are true and correct, and the Board so finds.

**Section 2. Change of Schools' Names.** The schools currently named Alliance and Elmhurst are renamed to a single merged school called Elmhurst United Middle School effective on August 1st, 2019.

**Section 3. Submission of CDS Application to CDE and Other Necessary Actions.** The Board hereby authorizes District staff, including the District's CDS Coordinator, to submit to the CDE the State-required application to rename the schools and to update the renamed and merged Alliance and Elmhurst CDS information; to take all other actions required by the State of California and by law to effect the aforementioned school name changes; and to take all other actions necessary within the District to effect the aforementioned school name changes.

**Section 4. Approval of Actions.** All actions heretofore taken and to be taken by District staff, as set forth above, are hereby approved, confirmed and ratified.

**Section 5. Effective Date.** This Resolution shall take effect from and after its date of adoption.


