**Action Requested** 

Approval by the Board of Education of Resolution No. 1112-0761 - Request for three month extension of bid with Sysco Food Service of San Francisco for frozen foods and groceries due to needing sufficient time to integrate the new meal program requirements into the bid document and items; the guidelines were received on April 27, 2011 and staff has been working to understand the regulations, identify current items that comply with regulations, and find new items that comply with regulations for the additional period of July 1, 2012 through September 30, 2012, in the amount not-to-exceed \$1,200,000.

**Background** 

The Nutrition Services Department is required to provide meals to needy children who meet federal eligibility criteria for free and reduced priced meals as defined in California Education Code section 49531 and 45552 respectively. The District has an agreement with California Department of Education Nutrition Services Division to provide meals under the "Child Care Food Program", breakfast under the "School Breakfast Program", lunch under the "School Lunch Program" and after school snacks under the "After School Snack Program."

Discussion

Nutrition Services is in the process of integrating the new Federal nutrition guidelines released in late April 2012 into the meal program. The menu reflecting the new regulations is near completion and a new bid for frozen food and groceries meeting these regulations will be completed by August 2012.

Recommendation

Approval by the Board of Education of Resolution No. 1112-0761 - a three month extension be made to Sysco Food Service of San Francisco, for an estimated amount of \$1,200,000.00 as indicated in Resolution No. 1112-0761.

**Fiscal Impact** 

Extension of the bid will result in monetary savings in frozen food and groceries.
