Subject **Certification of Unhoused Pupils as it Relates to Charter Schools’ Applications for Facilities Funding**

Action Requested Adoption by the Board of Education of Resolution No. 1718-0027 authorizing and approving Certification of Unhoused Pupils Related to Charter School Applications for Facilities Funding in accordance with applicable law.

Background and Discussion Pursuant to School Facility Program Regulation Section 1859.162 regarding General Preliminary Charter School Apportionment Eligibility Criteria, the Charter Schools listed below have submitted an application for Charter Schools Facilities Funding to the Office of Public School Construction.

As a condition of processing a Charter School application for facilities funding under the Charter School Facilities Program (CSFP), a resolution is required from the Governing Board of the local school district in which the Charter School is physically located, certifying the number of projected unhoused pupils, if any, that will be served by the proposed Charter School project.

Pursuant to CSFP Regulation Section 1859.162.1(a) the Oakland Unified School District Board of Education is required to discuss this issue as an action item at a regularly scheduled board meeting.

The following proposed Charter School projects are anticipated to be physically located within the boundaries of the following high school attendance areas within the Oakland Unified School District:

Resolution of the Board of Education of the Oakland Unified School District Resolution No. 1718 –0027

Certification of Unhoused Pupils as Related to Charter School Applications for Facilities Funding

WHEREAS, the Charter Schools listed below have requested that the Oakland Unified School District Board of Education discuss and certify to the number of projected unhoused pupils, if any, that will be served by the proposed Charter School projects, pursuant to School Facility Program Regulation Section 1859.162.1(a); and

WHEREAS, a condition of processing the Charter School applications under the Charter School Facilities Program is a resolution from the Governing Board of Education of the School District in which the Charter School is physically located which certifies to the number of District projected unhoused pupils, if any, that will be served by the proposed Charter School project; and

WHEREAS, pursuant to School Facility Program Regulation 1859.162.1(a) the Oakland Unified School District Board of Education is required to discuss this issue as an action item at a regularly scheduled, publicly held board meeting; and

WHEREAS, the proposed Charter School projects are anticipated to be physically located within the boundaries of the following High School Attendance Areas (HSAA) within the Oakland Unified School District:

Request for up to 850 pupil grants in grades K-12 (Approximately 65-66 per grade level)

Lighthouse Community Charter School (Lodestar) plans to request up to 850 K-12 pupil grants. Currently the school houses 234 K-6 pupils. The project is projected to serve an additional 616 K-12 pupils. The District currently has no eligibility in the K-6 category in this high school attendance area. Furthermore, the District does not consider the projected additional pupils unhoused, as the proposed new classrooms would draw from existing students currently housed within the District.

Therefore, there are 0 unhoused K-6, 0 unhoused 7-8, and 0 unhoused 9-12 pupils that would be served by the project.

Roses in Concrete plans to request up to 200 K-8 pupil grants. Currently the school houses 275 K-5 pupils. The project is projected to serve an additional 0 K-8 pupils. The District does not consider the projected additional pupils unhoused, as the proposed new classrooms would draw from existing students currently housed within the District. Additionally, a portion of the new facility is expected to replace existing classroom capacity included in the District's inventory. This calculation reflects the net additional classrooms only.

Therefore, there are 0 unhoused K-6 pupils and 0 unhoused 7-8 pupils that would be served by the project.
