Subject **Resolution No. 2021-0178 - Appointing Stakeholders to the Oakland Unified School District's Career Technical Education Advisory Group**

Action Requested and Recommendation Adoption by the Board of Education of Resolution No. 2021-0178 - Appointing Stakeholders to the District's Career Technical Education Advisory Group.

Background

(Why do we need these services? Why have you selected this vendor?)

Perkins Funds provides support to Local Educational Agencies in support of development of Career Technical Educational Programs. The Oakland Unified School District receives approximately \$450,000.00 annually from this program to support its CTE programs.

Perkins V requires LEAs to engage broad stakeholders in CTE program review and improvement plans every year, and Federal Program Monitoring of Perkins requires Board approval of said stakeholders. In addition, Education Code section 8070 requires the governing board of school districts participating in CTE programs to appoint a CTE advisory committee.

Accordingly, Oakland Unified is required to gain OUSD School Board Approval of the Roster annually.

Fiscal Impact Approval of CTE Roster will not have any direct fiscal impact but it will allow the High School Linked Learning Office of OUSD to apply for CTE grants as most require a CTE Advisory Group, i.e. Perkins V CTE Grant, Prop 51 CTE Facilities Grants, etc.

Appointing Stakeholders to the Oakland Unified School District's
Career Technical Education Advisory Group

WHEREAS, the United States Congress passed the Carl D. Perkins Career and Technical Education Act - *Strengthening Career and Technical Education for the 21st Century Act* ("*Perkins V*") to provide federal funding of Career Technical Education ("CTE") programs;

WHEREAS, *Perkins V* requires all eligible recipients of *Perkins V* funds to complete a Comprehensive Local Needs Assessment ("CLNA"), incorporating input from a diverse group of stakeholders, the results of which CLNA must be included in the application for funds;

WHEREAS, Education Code section 8070 requires that the governing board of each school district participating in a CTE program appoint a CTE advisory committee to develop recommendations on the program and to serve as a liaison between the district and potential employers;

WHEREAS, the Oakland Unified School District ("OUSD") intends to file an application for *Perkins V* funding for the 2020-2021 school year;

WHEREAS, OUSD intends to obtain the necessary stakeholder input for the CLNA, and meet its obligations under Education Code section 8070, by forming an OUSD CTE Advisory Group, which will be responsible for providing input on the annual updates to the CLNA and alignment of CTE programs with community employment needs;

WHEREAS, the stakeholders to be included in the OUSD CTE Advisory Group will be CTE teachers, guidance counselors, school administrators, parents and students, representatives of CTE programs at post-secondary education institutions, including faculty and administrators,

representatives of special populations, representatives of regional or local agencies serving out-of-school youth, homeless children and youth, and at-risk youth; and


