## RESOLUTION OF THE

## STATE ADMINISTRATOR AND THE BOARD OF EDUCATION OF THE OAKLAND UNIFIED SCHOOL DISTRICT RESOLUTION # 0809-0139

APPROVING AMENDED AND/OR NEW MASTER AGREEMENTS OR CONTRACT AND INDIVIDUAL SERVICE AGREEMENTS WITH NON-PUBLIC SCHOOLS AND/OR NON-PUBLIC AGENCIES FOR SPECIAL EDUCATION PROGRAM FOR FISCAL YEAR 2008-2009

WHEREAS, because of changing service needs of Special Education Students, it is necessary to provide greater programmatic and administrative flexibility to meet the needs of such students; and

**WHEREAS**, non-Public Schools and Non-Public Agencies are certified by the state to provide specialized educational services in a setting for Special Education Pupils that the District is not presently capable of providing "in-house;" and

**WHEREAS**, the number of students requiring services from Non-Public Schools and Non-Public Agencies have surpassed the current maximum cumulative total approved on October 8<sup>th</sup>, 2008 and November 19, 2008, respectively,

NOW, THEREFORE, BE IT RESOLVED that the State Administrator approves a Master Agreement or Contract, subject to form and content approval by the General Counsel on behalf of the District, with each nonpublic school or non public agency listed in Attachments "A" and "B" not to exceed the new or amended dollar maximum listed in said attachments to this Resolution and provided the revised cumulative total of all such Master Agreements or Contracts, at any time, do not exceed a cumulative total of \$12,813,637.00 for fiscal Year 2008-2009; and

BE IT FURTHER RESOLVED that the State Administrator further approves revised, amended or new Individual Service Agreements for an identified special education pupil, subject to form and content approval by the General Counsel, on behalf of the District, with said non-public schools or non-public agencies, named in Attachments "A" and "B" provided the cumulative total of all such Individual Service Agreements with said non-public school or non-public agency named does not exceed the maximum amount stated in the approved new or amended Master Agreement or Contract with said non-public school or agency as authorized by this Resolution; and

**BE IT FURTHER RESOLVED** that if either of the Master Agreement or Individual Service Agreement regarding expenditure of Special Education funds are, or shall be deemed, contrary to the federal or state law, or rules and/or regulations, the District shall conform such Agreements to such laws, rules and/or regulations; and

**BE IT FUTHER RESOLVED** that this Resolution supercedes Resolution No. 0809-0049 approved October 8, 2008 and Resolution 0809-0067 approved November 19, 2008.
