

APPROVING NEW MASTER AGREEMENTS OR CONTRACTS WITH NON-PUBLIC SCHOOLS AND/OR NON-PUBLIC AGENCIES FOR SPECIAL EDUCATION PROGRAM FOR FISCAL YEAR 2011-2012.

WHEREAS, the service needs of Special Education students necessitates greater programmatic and administrative flexibility to meet the Free and Appropriate Public Education needs of such students; and

WHEREAS, Non-Public Schools and Non-Public Agencies are certified by the State to provide specialized educational services in a setting for Special Education pupils that the District is not presently capable of providing "in-house;"

NOW, THEREFORE, BE IT RESOLVED that the Governing Board approves a Master Agreement or Contract, subject to form and content approval by the General Counsel with each Non-Public School or Non-Public Agency listed in Attachments "A" and "B" respectively, and further authorizes Individual Service Agreements to be issued, subject to approval by Board, subject to form and content approval by the General Counsel, in a total amount Not To Exceed \$18,000,000.00, for the fiscal year 2011-2012.
