NEGOTIATIONS BETWEEN OAKLAND UNIFIED SCHOOL DISTRICT ("District") AND UNITED ADMINISTRATORS OF OAKLAND SCHOOLS ("UAOS") FOR A FULL SUCCESSOR AGREEMENT

UNITED ADMINISTRATORS OF OAKLAND SCHOOLS LIST OF INITIAL PROPOSALS

As you may know, the United Administrators of Oakland Schools (UAOS) and the Oakland Unified School District (District) have been involved in Re-Opener negotiations on a very limited number of issues, specifically on UAOS Article 12: <u>Salary Compensation</u> and Article 6: <u>Performance Evaluation</u> & related Appendix 6.1 (Certificated P.E. Form) & Appendix 6.2 (Classified P.E. Form). The UAOS and the District will begin negotiations for a full Successor Agreement in September 2009 and, as such, both parties shall be expanding the scope of negotiations to include additional articles beyond those currently being discussed in the re-opener phase, and have agreed to close the re-opener. The parties have agreed to incorporate all tentative agreements (TAs) or Side Letters of Agreement already jointly agreed to during the re-opener negotiations, if any, into the upcoming negotiations for a Successor Agreement.

The current agreement between the United Administrators of Oakland Schools (UAOS) and the Oakland Unified School District (District) expired on June 30, 2009. In preparations for upcoming negotiations for a full Successor Agreement, the UAOS submits the following Articles for proposed changes to the existing Agreement with the District effective July 1, 2009.
