**Subject** **Declaring Obsolete, Surplus and Sale of District Personal Property**

**Action Requested** Approval by the Board of Education of Resolution No. 1415-0036 Authorization to Declare Obsolete Multi-functional Copiers Surplus Property and Authorizing Sale as stated herein.

**Background** After generation of an inventory of material in Distribution Center, some items were found to be surplus, obsolete and of no further use to the District. It is the recommendation of the Superintendent of Schools that such items be declared surplus and sold in accordance with Education Code Sections 17545 and 17546, respectively.

**Recommendation** Approval by the Board of Education of Resolution No. 1415-0036 Authorization to Declare Obsolete Multi-functional Copiers Surplus Property and Authorizing Sale as stated herein.

**Fiscal Impact** Sale of the items listed in Exhibit "A" will reduce the cost associated with storing of obsolete and outdated materials and provide financial returns on items that would otherwise generated disposable expense.
