**ACTION REQUESTED:**

Acceptance by the Board of Education of Grant Award from the California Department of Social Services, Refugee Programs Bureau, to support refugee school-age students who have been in the United States for three years or less, for all OUSD schools for fiscal year 2014-2015, in the amount of \$27,518.00, pursuant to the terms and conditions thereof.






