Chairperson Hodge introduced Brad Stam, Chief Academic Officer. Mr. Stam used a PowerPoint for his presentation on the mission statement, overview of high school team sports, governance, eligibility requirements, academic support systems, and challenges of the OAL. Mr. Stam said the goal of the OAL is to provide sportsmanship and foster the development of good character by conducting school sports programs in a manner that enhances the academic, emotional, social, physical, and ethical development of students, athletes, and teachers positive life skills that will lead to personally successful and socially responsible lives.

Mr. Stam reviewed information on teams across the different high schools and sports programs offered at each school. He said there are 11 boy sports and 10 girl sports. The budget allocation for boy sports is \$5,200 per school and \$3,520 for girl sports per school. The total budget for OAL for this year is \$877,716.00.

Mr. Stam said there was a question on governance. He said the league is governed by the OAL Rules and Regulations and the CIF Rules and Regulations. There was a question about eligibility requirements and Mr. Stam read CIF205.(1)c Eligibility Requirements and Scholastic Eligibility. Information was reviewed regarding the academic support for student athletes and recognition of student athletes. There has been more emphasis on academic achievement of OAL student-athletes and their respective teams. Mr. Stam reviewed the Academic profile of 2009-10 Teams.

Mr. Stam stated the OAL office has limited support of a half-time commissioner and a half time classified support staff. Responding to data requests can be difficult given the paper and pencil record keeping systems. AERIES does not have an OAL field designated for student athletes. In addition, there are issues of hiring team coaches in a timely manner; and coaches have not received an increase in salaries for many years. All schools do not

have tutoring programs which target student athletes. There is lack of funding to support teams needing specialized equipment for individual sports, training equipment, and uniforms; transportation costs for students to get to games; and there is limited access to a computer data system for OAL that allows schools and the OAL to manage student information and recognize student athletes.

Mr. Stam noted Committee members were given information on the screening, hiring, training and supervising coaches. It shows the list of support programs at each of the schools that are available to students.

Director Yee stated he is concerned that the GPA standard for participation is the wrong standard. Director Yee asked how many of the services at the high schools are used by the student athletes? It is our responsibility to see these students graduate from high school ready for college and career.

Director London asked what are the options for students in alternative programs to participate in team sports? Which sports are dual sports? Why do boys sports get almost \$2,000 more per school than girls? She said the academic profile seems incomplete and the GPA for the Fremont Boys football team is not listed. Director London said she shares a concern that the Interscholastic Federation eligibility requires a "C" average. People could do more. She requested information on participation rates. How many kids are in each of these sports? Where do they come from?

Chairperson Hodge said this item is ready for the Second Read. Some of the challenges and dilemmas in the material seem clear pieces of the resolution, i.e., AERIES is not connected. A resolution needs to be operationalized in some way and it needs to be a roadmap for the infrastructure of the OAL in terms of staffing. Also, the resolution provides the clarity for her around the link to academics and athletics, in that it speaks about preventing kids from losing class time and we are dedicated to academic supports. She wishes to continue the dialog around the dilemmas and the challenges as to the responses and answers.

Chairperson Hodge said there has been discussion about raising the bar as far as students passing the CAHSEE. For the students who do not have a sense of pathway, our athletic program should be the place to find a pathway to their life and career. Chairperson Hodge asked if there is a way to dig a little deeper around who those students are and how we might support them better. The question is important, too, around why boy sports receive more funding than girl sports.

Mr. Stam said the football program is a costly program to operate and it is the main one that is significantly different between boys and girls sports. Regarding academic support, the key issue was that not all schools have tutoring programs targeting student athletes. All schools have tutoring programs, but whether or not there is an individual at each school whose responsibility is to provide extra support to student athletes to stay focused on keeping their GPA is an open question. Mr. Stam noted Commissioner Moore has said that it depends on the coach and that the coach is only focused on GPAs when the coach is actively working on a particular sport. If it is a spring sport, that coach may not be working in the fall or thinking about the need to support athletes who are going to be in that varsity sport in the spring to keep up their GPA. Since the CIF rule determines eligibility based on a prior semester GPA, that is a critically important fact. If the coach

has a longstanding relationship with the school, principal, is able to foster those connections, and is able ensure that the students get supported with a homeroom teacher or an adviser, then it probably is more likely to happen. Mr. Stam said the Commissioner has repeatedly noted the issue of inadequate resources to effectively run the program. Mr. Stam said he does not know how Oakland stands budget wise in terms of the number of students served in comparison to other districts, but many school districts have been cutting back on their athletics programs because of the budget crisis.

Mr. Stam said there may be a possibility now that we have more accurate data about student's academic status to do more targeted referrals than in the past when the data was not very accurate. We still come up with the question of who is going to do it and take the responsibility on for these kids. With regard to Director Yee's idea of instead of maintaining a GPA, the students might be required to pass the CAHSEE in order to participate, Mr. Stam said we can do more analysis to determine the impact on the current varsity sports participants if we had made that requirement last year or the year before and determine the number who have passed the CAHSEE. Graduation is a motivation for passing the CAHSEE, however, graduation occurs at the end of the 12th grade. Participating in varsity sports could occur as it is the tenth grade rite. It could motivate students to stay focused earlier. It would merit discussion with the policy committee of the OAL to get the reaction of the principals.

Director Yee said if the reason a kid comes to school is to play sports, he would rather have him in school with the possibility that a student could have a mentor or latch onto some social networks and affiliations that are positive. At the same time, it is the adult's responsibility to ensure students make it all the way through the system and that they do not make choices that are counterproductive.

Chairperson Hodge said to move this forward, as we come up with these suggestions, she asked Mr. Stam about his thoughts of doing a deeper analysis and to possibly take this issue to OAL Policy Committee to think about engaging coaches in a different way. She asked Mr. Stam about whose desk that would fall on and what is the feasibility of adding it to the workload? Is it shared? Is it just the Commissioner? Mr. Stam said we need to be judicious about the amount of additional analysis that we are asking for given the fact that the Commissioner has made it very clear he is barely keeping his head above water as it is. Mr. Stam said it may be worthy to have some dialog with the OAL Policy Committee Members to figure out a forum that would not violate the Brown Act that could be an opportunity for dialog. Chairperson Hodge said a special meeting could be called. Mr. Stam said the Chairperson could attend the OAL Policy Committee Meeting and have some exploratory dialog.

Mr. Stam said he is unsure about the extent of awareness around the resolution and the resolution language and that could be another forum. One of the anticipated responses is going to be if the Board wishes to raise the bar around athletics and OAL, the question may involve finding resources and that becomes an issue of priorities.

Public Speakers on this Item:

Michele Hamilton, Director of the After-School Programs for the District, said there is a wide variety of services for all students. There are programs targeting student athletes and those programs could serve as models. Skyline High and Oakland Tech have programs that

target student athletes. Tech pays their coaches a small stipend for tutoring sessions with their teams. The students will have consequences if they are not in the tutoring sessions. The program at Tech has been very successful and they have the most eligibility of athletes in the District. Ms. Hamilton said they have met with principals at the big schools to look at replicating that model and they found the challenge to be the buy in of the coach which varies depending on the site. She has met with Commissioner Moore about the possibility of creating the culture of buy in of the coaches at the OAL Policy Committee meeting so that their services are readily available. Ms. Hamilton said she has a comprehensive list of all of our services. She talked about some of the challenges in providing after school services. There are no lights at the Fremont site and student athletes are tutored during the lunch hour or after school. Ms. Hamilton said CAHSEE prep, credit recovery and tutoring are offered at every school. The issue is that we are not getting our kids to the services.

Ms. Hamilton said our after school programs in the Alternative Education sites offer sports leagues. There is a basketball league, co-ed soccer league, and the beginnings of a flag football league. If we want our students to pass CAHSEE, students should be required to pass the test in order to participate in the sports leagues.

Director Yee said it would be a straightforward way of doing it. Students pass the CAHSEE and they are forever eligible. If the students do not pass it, they have to demonstrate their ability to do it. Director Yee asked Ms. Hamilton about the number of students who go through her program in a semester. Ms. Hamilton stated they serve over one-half of the K-12 population. They are under serving in high school. They have an after school programs evaluator and they have been talking about tagging student athletes who are in the program to get more significant data.

Harold Pearson, Executive Director of SPAAT - Student Program for Academic and Athletic Transitioning - said it is important to have collaboration and infrastructure. This has to come down from the top and everybody has to be on the same page. The NCAA is taking away scholarships from schools that are not participating or graduating their student athletes. He recommended doing something similar. There are ways to do it with the CAHSEE and the requirements and support. A lot of athletes have issues with not making it to after school programs.

Kim Shipp said the District has tons of academic after school support for student athletes and other students in the District. The problem is getting students to participate. In order to have total buy in, it must be a requirement. Student athletes should be required to attend after school tutoring. It goes back to all the talk of extended day. We have many programs we can use as extended day for our students. She suggested that students be programmed in an after-school program.

Director London said there may be other options for kids who love sports who are not going to make it into the NFL. There may be ways we can show kids how to have sports be part of their lives professionally without being an athlete. We might explore a way to include the Raiders, Oakland A's and the CAL Bears Athletics Department.

Chairperson Hodge said there is a piece in the report that refers to recognition of student athletes. She wants to see that happen. There are organizations we could partner with to provide some infrastructure. It might require philanthropic dollars to fund it and she would

like to see someone take that on. Chairperson Hodge said the resolution refers to KDOL doing some specific things around it.

Director Hodge acknowledged that there are mentors who have to step up and play a role. She wants to ensure we do not take advantage of the kids and that we acknowledge the people who are willing to give up their time to work with these kids.

Mr. Stam said that students only take the CAHSEE once in tenth grade, whereas for GPA the students are getting feedback on process each semester. The ninth grade teachers are giving them progress reports more frequently. It would be great for the OAL Policy Committee to engage with us and a focus on academic core and not just CAHSEE prep. That might be a way to build in both and raising the bar all the way around.

Mr. Stam spoke to the issue of volunteer involvement. With regard to games, there may be a significant amount, but in terms of support services surrounding each sport, he does not know the extent to which the OAL is organized to mobilize or leverage volunteers.

Mr. Stam said that Ms. Hamilton's idea of how to identify and leverage the after school funding resources is a great idea because it is a dedicated funding source that we do have available to us. He is hoping that Commissioner Moore and the OAL Policy Committee can do more creative thinking about how to leverage the dollars.

Kim Shipp said she helped a student review his transcript which indicated the student passed Algebra I in 8th, 9th and 10th grades. She said the District should develop a mechanism to evaluate transcript evaluations. There may be similar patterns for other students which needs to be corrected. Chairperson Hodge asked Brad Stam to follow up with Ms. Shipp. Mr. Stam said we will address this issue directly on April 19 as part of the A-G For All Progress Indicators update. He said this has been an important focus of professional development for the counselors. We can share data on the transcript audits that have already been done.

I. Superintendent of Schools or Designee's Committee Liaison Report

Brad Stam, Chief Academic Officer, stated the next meeting date for this committee was changed from April 5 to March 30. The focus of the meeting will be Effective Instruction. Presentations are scheduled by elementary staff on Teach for Success and by the Middle

and High School Network Officers and staff on Effective Instruction. Mr. Stam said there will be discussion regarding recommendations for sustaining and building upon the Effective Instruction Priority of the Board and Superintendent (OE-11 and OE-06).

Mr. Stam said he had a question of coordination with the Finance and Human Resources Committee. Director Kakishiba has desired to create a task force around Teacher Effectiveness.

Mr. Stam gave the focus of upcoming Committee Meetings:

April 19: The focus will be college and career readiness, A-G Progress indicators, a presentation on Linked Learning; our West Ed Partnership; and a discussion on Grading Policy with a principal presentation.

May 3: The focus will be on safe and supportive schools. There will be a presentation on Positive School Climate, Progress Indicators and plan for restorative justice and violence prevention. If there is time, there will be an overview of our GATE Program.

May 17: There will be a discussion on the Retention Policy.

June 1: There will be a discussion of Best Practice Sharing and another review of academic priorities for 2010-11.

Mr. Stam said there was a request to do a presentation on our overall district calendar. That will be agendized for the next meeting.

Mr. Stam talked about the recent debate tournament in San Francisco. Oakland took three of the top four honors.

Acting Chairperson Yee said he understood the Teacher of the Year process is in full swing. He asked staff to calendar that item.

Acting Chairperson Yee asked if the piece on academic priorities included the Operational Expectations? Mr. Stam said we could agendize the review of the OEs on the calendar. Acting Chairperson Yee said he was looking at May 17 or June 14. The OEs are designed to provide the superintendent with his work plan for the next year, and it would be good for us to aim for May 17 date if that is possible. The number of OEs for Teaching and Learning was reduced to approximately five.

J. Introduction of New Legislative Matter

Director London said Berkeley Unified recently adopted a Resolution put forth by Our Family Coalition around issues related to tolerance in school climate and the Lesbian Gay Bisexual Transgender (LGBT) community is lobbying the District to adopt a similar policy. She said we should be proactive in looking at this. Is there a way we can plug that in with the restorative justice work?

Acting Chairperson Yee asked if the Committee will be hearing about I-3 grant money applications. Mr. Stam said we are in discussions on multiple I-3 partnerships potential.

We are looking at a Pre-K-3 complementary learning area, leadership development, multiple pathways, linked learning and college readiness. One of the phenomena about the I-3 and the whole Race to the Top is that because the State made it so open ended, everyone is scrambling and partnering and trying to figure out the magic combination of partners and focus to get one of the grants. The grants range from \$50,000,000 for a program with a proven track record to \$5,000,000 level for innovative programs. Mr. Stam mentioned the school improvement grants. He was in Sacramento last Thursday speaking before the State Board because of the last minute nature of the announcements of the schools that are on the "persistently under performing" list and the change to that lists for Title I schools and one list for non Title I schools. He stated the State Board did pass waiver requests to extend the timeline. This does affect us because we will have four schools on the list: Elmhurst Community Prep, Alliance Academy, Roots Academy and United for Success. We will have the option to apply for funds. It requires that we pursue one of four options: Close/Consolidate Model; Restart Model (charter conversion); Turn Around Model and Transformation Model. The Turn Around option provides for replacement of the principal and at least 50 percent of the staff. The Transformation model involves extended learning opportunities, differentiated compensation for staff, and intensive professional development. While the Deputy Superintendent at the State level did say that these are application programs, there was a comment by the executive director of the state board that LEAs should not think that if the schools do not apply that the same requirements may not apply in the future. It is expected there may clean-up legislation to essentially force schools, whether or not they apply for these dollars, to pursue one of the four options. The question was asked about the issue of district charter conversion. Would a district be eligible to be the education management organization, to which the reply was "Yes". The legislation is silent on the requirements for what that would look like. That is an area of interest that districts are looking at. Mr. Stam said if a school has hired the principal within the last two years, they are not required under these options to replace the principal. However, if the principal has been in place more than two years, they are required to replace the principal.
