WHEREAS, School Site Councils shall nominate one parent member as a LCAP Parent Advisory

candidate on the school's "SSC Roster" and elections will take place at the annual fall SSC Summit (on October 25, 2014 for the 2014-15 school year). Participating SSC Parent members will break up into electoral districts, hear from their parent nominees (speeches), and vote for their 4 representatives such that 28 members are selected for the Parent Advisory Committee. From those members, at least 8 members will be selected for the EL Parent Sub-Committee in approximate proportion to each electoral district's enrollment of English Learners as well as interest and availability.

NOW THEREFORE, BE IT RESOLVED THAT, the governing board of the Oakland Unified School District does hereby establish the LCAP Parent Advisory Committee and LCAP English Learner (EL) Parent Sub-Committee.
