Agencies Contracts for the 2010-2011 School Year

ACTION REQUESTED

Approval of Resolution Number 1011-0161 to allow the district to enter into and execute revised, amended, or new master agreements for Non-Public Schools and Non-Public Agencies for Special Education Programs for Fiscal Year 2010-2011 and to enter into and execute revised, amended or New Individual Service Agreements for Special Education students for Fiscal Year 2010-2011 in an amount, cumulatively, not to exceed \$14,451,132.88.

BACKGROUND/DISCUSSION

Federal Law and California Education Code require a Special Education Local Plan Area (SELPA) to provide a full continuum of program options, to include Non-Public Schools (NPS). When a school district or SELPA does not have an appropriate public education program for a student, a non-public school shall be made available. The District places students in a NPS for services such as: Day Treatment, Residential Treatment, Extreme Behaviors and Severely Disabled students.

This Amendment to Resolution Number 1011-0161 is necessary to meet the adjustment of student enrollment needing specialized care, to meet their educational needs as deemed through their Individual Education Plan and corrects an inadvertent error in the Attachment A & B to Resolution No. 1011-0130.

FISCAL IMPACT

The total cost for the Master Agreements and Individual Service Agreements for services to Special Education students utilizing Non-Public Schools and Non-Public Agencies, funded by Programs for Exceptional Children for Fiscal Year 2010-2011, is projected to not exceed \$14,451,132.88. Of the foregoing sum, \$311, 310.00 is ARRA (American Recovery and Reinvestment Act) funding.

RECOMMENDATION

Approval of Resolution No. 1011-0161 to allow the district to enter into and execute revised, amended, or new master agreements for Non-Public Schools and Non-Public Agencies for Special Education Programs for Fiscal Year 2010-2011 and to enter into and execute revised, amended or New Individual Service Agreements for Special Education students for Fiscal Year 2010-2011 in an amount, cumulatively, not to exceed \$14,451,132.88.

WHEREAS, the changing service needs of Special Education Students necessitates greater programmatic and administrative flexibility to meet the Free and Appropriate Education needs of such students; and

WHEREAS, Non-Public Schools and Non-Public Agencies are certified by the State to provide specialized educational services in a setting for Special Education pupils that the District is not presently capable of providing "in-house;" and

WHEREAS, the Non-Public Schools and Non-Public Agencies serving the specific needs of OUSD students has adjusted, and the level of service to students required to meet the current needs, has not surpassed the maximum cumulative total approved on March 23, 2011, Enactment No. 11-0474,

NOW, THEREFORE, BE IT RESOLVED that the Governing Board approves a Master Agreement or Contract, subject to form and content approval by the General Counsel, with each Non-Public School or Non-Public Agency listed in Attachments "A", and "B" respectively, in an amount, cumulatively, not to exceed \$14,451,132.88, for the Fiscal Year 2010-2011; and

BE IT FURTHER RESOLVED that the Governing Board further approves revised, amended or new Individual Service Agreements for an identified special education pupil, subject to form and content approval by the General Counsel, with said Non-Public Schools and/or Non-Public Agencies, named in Attachments "A", and "B", or other Non-Public Schools and/or Non-Public Agencies that may be required, provided the cumulative total of all such Individual Service Agreements do not exceed \$14,451,132.88, as authorized by this Resolution; and

BE IT FURTHER RESOLVED that the Superintendent of Schools may enter into and execute the revised, amended or new Individual Service Agreements on behalf of the District with non-public schools or agencies provided the cumulative total of all such Individual Service Agreements not exceed the cumulative total of the approved Master Agreement with said entity;

BE IT FURTHER RESOLVED that the Secretary of the Board shall place said Individual Service Agreements on the Consent Calendar of the Board for ratification at least every thirty calendar days;

BE IT FURTHER RESOLVED that if either the Master Agreement or Individual Service Agreement regarding expenditure of Special Education funds are, or shall be deemed contrary to the Federal or State law, or rules and/or regulations, the District shall conform such Agreements to such laws, rules and/or regulations; and

BE IT FURTHER RESOLVED that this Resolution supersedes Resolution No. 1011-0130 approved March 23, 2011, Enactment No. 11-0474.
