ACTION REQUESTED:

Adoption by the Board of Education of Resolution No. 1516-0153 Amendment No.1, Grant Contract No. CCTR-5008 from California Department of Education to provide funding for General Child Care and Development Programs for the Early Childhood Education Department, increasing Reserve Account by the amount of \$9,570.00 increasing the Maximum Reimbursable Amount (MRA) encumbered amount from \$2,586,566 to \$2,596,136 for the period July 1, 2015 to June 30, 2016, pursuant to terms and conditions thereof, if any. All other terms and conditions of the Agreement remain in full force and effect.





