Why were you unable to expend all your funds in 2019-2020 school year? We had several reasons why we were not able to spend our Measure N funds in 2019-2020. First, we allotted funds for a leadership consultant, but were never able to secure an appropriate contract with a quality consultant, so that did not occur. Secondly, several of our pathway associated field trips were canceled due the shelter-in-place orders that started on March 13. Futhermore, we were not able to spend these funds on supplies because of the freeze in purchasing from a district level around supplies for last school year.
