## TRIAL ON-LINE SPEAKER CARD REGISTRATION

*The Measure G1 - Districtwide Teacher Retention and Middle School Improvement Act Oversight Commission, in its desire to take more targeted Public Comment on Agenda Items, on a trial basis, within the current times allotted for Public Comment, is returning to its past practice of taking individual Public Comment on most items on the Agenda (except Consent).
