(A)(1) Arrests by OSPD on OUSD School Sites for School Related Offenses

- **08MAR18- Elmhurst**

12, Male, Black, Robbery, No IEP/ 504

13, Male, Black, Robbery, IEP

Officer responded on a report of a robbery that had occurred on campus. Victim stated the suspects held him against a fence, went through his pockets, then grabbed his phone. Victim attempted to hold on to his phone, at which time was struck on the face by the suspects, forcing him to let it go. Victim and victim's parents wanted to press charges on the suspects. Suspects' parents were notified and released to their custody.

- **07JUN18- Rudsdale**

18, Male, Hispanic, Robbery, No IEP/ 504

Officers responded on a report of an armed robbery. Victim told the officers that the suspect approached him, simulated a firearm in his waist, and demanded the victim's phone. Fearing for his safety, the victim complied. Another victim approached the officers and advised that they too were robbed. While interviewing the victims and witnesses, the suspect drove by the scene. Victims and witnesses pointed the suspect out and officers stopped the suspect. Suspect admitted to stealing the phones and told the officers were he had thrown the phones out of his window. Victims wished to press charges on the suspect.

(A)(2) Arrest by OSPD on OUSD school sites for non-school related offenses.

- **17APR18- Elmhurst**

14, Male, Hispanic, Domestic Battery, No IEP/ 504

Officers responded on a report of a domestic battery that occurred while the victim was on her way to school. Victim told officers her ex-boyfriend grabbed her by her arms by force and took her cell phone to prevent her from calling for help. The suspect then refused to let go of the victim when she asked him to. Victim stated it was not the first incident in which the suspect used force on her.

- **24MAY18- Fremont**

17, Male, Hispanic, Robbery, No IEP/ 504

Officers responded to a report that a student was robbed by another student at home. Victim advised the officers that the suspect and his friend pulled a knife out on him, and took his phone from his person. Victim was in fear and reported the incident due to the suspect attending the same school. Victim wished to pursue charges against the suspect.

(A)(2) Arrest by OSPD on OUSD school sites for non-school related offenses.

- **04MAY18- Oakland International High School**

- 17, Male, Hispanic, Lewd and Lascivious Acts upon Child, IEP**

- Officers responded to an elementary school on a report of a student who was molested by her brother. Officers spoke with the victim and staff member who disclosed several years of molestation by her brother. Victim advised there was another sister in the residence, and was in fear the same would start to happen to her. Victim/ Suspect's parent was on scene and unaware of the molestation. Victim wished to pursue charges against the suspect. Officers relocated to Oakland International, and took the suspect into custody.

- **25JAN18- Oakland International High School**

- 18, Male, Hispanic, Lewd and Lascivious Acts upon Child, No IEP/504**

- Officers responded to a high school on a report of a student who was molested by her cousin. Officers spoke with the victim who disclosed that her cousin was touching her in a sexual manner at home. Victim told the officers the suspect was confronted by her family regarding the touching, however it continued. Victim told the officers the suspect lives in the same residence and she was in fear the touching would escalate. Officers relocated to Oakland International, and took the suspect into custody.

Section (D) Complaints Against Police Officers/ School Security Officers

- 01/18/2018: School staff filed a complaint against a school security officer for failing to perform his/her duties by not investigating a 911 hang up call. **(Sustained)**. Investigation time spent on this complaint was six (6) hours.
- 01/25/2018: School staff filed a complaint against a school security officer for failing to perform his/her duties by not breaking up a fight between students. **(Sustained)**. Investigation time spent on this complaint was nine (9) hours.
- 02/05/2018: A parent of a student filed a complaint against a school security officer for rude conduct and using offensive language or abusive conduct. The school security officer allegedly threaten a student's family member and was seen driving by the student's residence. **(Not Sustained)**. Investigation time spent on this complaint was five (5) hours.

Section (D) Complaints Against Police Officers/ School Security Officers

2/13/2018: A parent of a student filed a complaint against a school security officer for rude conduct and using offensive language or abusive conduct. The school security officer allegedly made comments to a student and the student felt he was being threaten (**Not Sustained**). Investigation time spent on this complaint was six (6) hours.

04/29/2018: A parent filed a complaint against a school security officer for using excessive force against a student and rude conduct by using offensive language or abusive conduct. The school security officer allegedly bumped into the student intentionally and used profane gesture toward the student. (**Not Sustained**). Investigation time spend on this complaint was five (5) hours

Section (D) Complaints Against Police Officers/ School Security Officers

- 05/16/2018: School staff filed a complaint against a school security officer for conduct unbecoming while in performance of his/her duties. The school security officer allegedly was holding marijuana for a student during school hours. **(Unfounded)** Investigation time spend on this complaint was three (3) hours.
