**ACTION REQUESTED**

Approval by the Board of Education of Resolution No. 1112-0065, application for one (1) District Intern Single Subject Physical Education Teaching Credential.

**BACKGROUND**

The District Intern Certificate Program was enacted in 1983 under a major education reform law. This statute created an alternative route into teaching through District developed and administered teaching internships. The District, in collaboration with Fortune School of Education, allows individuals to provide instructional services while completing course work and the requirements towards the professional clear teaching credential. District Interns must be approved by the School District's Governing Board in order to participate in this collaboration. Upon completion of all requirements under California Education Code 44328, the Commission awards the credential to interns upon the recommendation from the School District's Governing Board.

**DISCUSSION**

One (1) individual has successfully completed the requirements for admission into the Fortune School of Education District Intern program and is being recommended for a District Intern Single Subject Physical Education Teaching Credential so he may work in the District for the 2011-2012 school year, with a District Intern Single Subject Physical Education Teaching Credential.


