PLEASE TAKE NOTICE that the Governing Board (Board) of the Oakland Unified School District will hold a Public Hearing at 8:00 P.M., December 15, 2021 at its Regularly Scheduled Meeting for the purpose of presenting certain findings, taking public comment, and approving a Resolution adopting the findings and approving an Energy Services Contract with Forefront Power LLC, for cost savings the District will realize through the purchase of electricity resources through a Power Purchase Agreement serviced by solar PV systems across 26 District school sites in accordance with California Government Code Section 4217, et seq.

The Solar Power Purchase Project under consideration is the purchase of electricity resources through a Power Purchase Agreement serviced by solar PV systems across 26 District school sites anticipated to produce a decrease in utility costs, increase in resiliency benefits and reduction of District-related carbon emissions. The Board's findings and the Power Purchase Agreement with Forefront Power LLC shall require that the anticipated cost for energy provided by the energy conservation facility will be less than the anticipated marginal cost of electrical purchases without the energy conservation facility.

The Public Hearing, as stated herein, will be held in the Great Room, LaEscuelita Education Center, 1050 2nd Avenue, Oakland, CA 94606-2291, via internet streaming via Zoom and/or Granicus Live Manager, simultaneously.
