#### ACTION REQUESTED

Approval by the Board of Education of Resolution No. 0809-0107- Naming the New Auditorium at Castlemont High School the "Phil Reeder Performing Arts Center".

### **BACKGROUND**

In accordance with Board Policy BP 7310, community members and the site administrators at the Castlemont High School campus request that the Board of Education formally name the new Castlemont Auditorium, the "Phil Reeder Performing Arts Center".

Phil Reeder was the choral director and later chairman of the Music Department at Castlemont for 14 years (1970-1984). During his tenure as musical director extraordinaire, he established a tradition of professionalism at the Castlemont campus.

The Castleers gained prominence in the early 70's under the late Mr. Reeder's direction. Under his leadership, the Castleers performed nationally, as well as internationally. They became student Ambassadors for the City of Oakland.

## FUNDING SOURCE

The costs associated with the purchasing of the signage for the auditorium are minimal. The overall project is funded from the General Obligation Bond-Measure B.
