




SUBJECT: Correction of Resolution No. 1213-0188 – To Correct Salary and Extend the End Date for Short-term, Temporary Fellowship/Residency Education Pioneers position.

ACTION REQUESTED

Approval by the Board of Education of Resolution No. 1314-1027– to correct the salary and extend the end date for the Temporary Fellowship/Residency position, as specified.

DISCUSSION

The Board, as requested on June 26, 2013, approved Resolution No. 1213-0118, Enactment Number 13-1367, which created a Short-term, Temporary Fellowship/Residency Education Pioneers position not requiring certification. It provides that the salary will be \$65,000 plus health benefits and that the employment of such Fellow/Resident will end no later than April 30, 2014. Both the salary and the date are incorrect.

The Board is requested to correct, in part, the June 26, 2013, action by adopting Resolution No. 1314-1027.

BUDGET IMPACT

There is no budget impact.

RECOMMENDATION

Correction of Resolution No. 1213-0188 – To correct salary to \$45,000—as agreed on the Memorandum of Understanding—and extend the end date to August 31, 2014 for the Short-term, Temporary Fellowship/Residency Education Pioneer position.

Pioneers Position -

WHEREAS, on June 26, 2013, by enactment #13-1367, the Board of Education approved Resolution No. 1213-0188 - Creation of Short-Term, Temporary Fellowship/Residency Position Not Requiring Certification (Education Pioneer Fellow); and

WHEREAS, said Resolution No. 1213-0188 provided for the creation of the Education Pioneer Fellows' Position at \$65,000 in salary plus health benefits but should have been \$45,000 in salary plus health benefits; and

WHEREAS, said Resolution No. 1213-0188 provided the Education Pioneer Fellows' temporary employment position shall end no later than April 30, 2014 but should have been no later than August 31, 2014,

NOW, THEREFORE, BE IT RESOLVED, that the Board approves the changes reflected in WHEREAS clauses 1 and 2 herein retroactive to June 26, 2013 with all other terms and conditions, if any, approved in Resolution No. 1213-0188, remaining in full force and effect.
