Approval by the Board of Education of Resolution No. 1011-0055 – in honor of National Family Literacy Day, November 1, 2010, declaring November 2010 as Family Literacy Month and recognizing and celebrating accomplishments of OUSD's Family Literacy

Program staff and families.

Discussion

The start of the 2010-2011 school year has seen the successful expansion of the Oakland Adult and Career Education (OACE) Family Literacy Program to a total of 25 OUSD schools.

Family Literacy is an instructional program designed to support children's academic achievement by assisting adults who are parents to obtain the educational skills necessary to become full partners in the education development of their children.

The National Family Literacy model recognizes the importance of parent learning for their effective support of childrens' experience both in and out of the classroom. The OACE Family Literacy Program offers English as a Second Language, Basic Education and Computer Literacy for parents at their childrens' school sites. It incorporates four components: 1) Children's Education, 2) Adult Basic Education, 3) Parent Time, and 4) Parent and Child Together (PACT) Time; all these components are brought together to support family involvement in schools which leads to better achievement for children.

The National Center for Family Literacy has recognized Oakland Unified School District for this effort, and for the alignment between the development of Family Literacy programs and the commitment to become a Full Service Community District. This recognition has been expressed through the donation of 4,000 children's books for distribution to Oakland's families.

In recognition of the value of Family Literacy to OUSD children and families, and to acknowledge and celebrate the efforts and accomplishments of OACE Family Literacy staff and the schools they serve, the Board is requested to approve the attached resolution.

WHEREAS, the Oakland Family Literacy Program integrates the four Family Literacy components: 1) Children's Education, 2) Adult Basic Education, 3) Parent Time, and 4) Parent and Child Together (PACT) Time; and

WHEREAS, family involvement in schools leads to better achievement for children²; and

WHEREAS, the Oakland Family Literacy Program has expanded implementation of ESL Family Literacy to at least twenty five District schools in 2010-11; and

WHEREAS, the Oakland Family Literacy Program promotes Computer Literacy for parents through the mobile classroom and in school computer labs; and

WHEREAS, the Oakland Family Literacy Program promotes Math Literacy through 'pathways to GED' for parents at District school sites, and

WHEREAS, the Oakland Family Literacy Program is aligned with the newly developed Strategic Priorities that have been established to develop Full Service Community Schools in the District,

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education, joined by the Superintendent of Schools, hereby designates November 1, 2010, as Family Literacy Day and the month of November, 2010 as Family Literacy Month in the District, respectively, and salutes and honors the efforts and accomplishments of the parents, guardians, caregivers, teachers, staff and administrators of the Oakland Family Literacy Program.
