Re: 2008-2009 Report – Implementation of Board Adopted 2008-09 Recommendations

Below is a summary report on the Implementation of Board Adopted 2008-09 Recommendations Regarding the Oakland Athletic League:

1. That the OAL continue as a separate and distinct section of the California Interscholastic Federation (CIF); and
The OAL has remained as a separate and distinct section of the California Interscholastic Federation (CIF) and expanded by 12 teams by adding a new league: the Bay Area Charter School Athletic Conference (BACSAC)
2. That the OAL monitor all OAL athletes through designation in AERIES on a weekly basis:
The OAL monitored all OAL athletes through designation in AERIES each marking period aligned with OAL/CIF eligibility dates
3. That the OAL require for OAL athletes academic assistance/enrichment outside of regular school hours (after school and Saturday) as needed; and
The OAL communicated athletic directors meetings, and coaches meetings the expectation that athletes would receive academic assistance/enrichment outside of regular school hours (after school and Saturday) as needed; **NOTE: This remains a challenging area of great need.**
4. That the OAL move Soccer to Winter for Boys and Girls for the 2008-09, 2009-10 seasons; and
The OAL has moved Soccer to Winter for Boys and Girls for the 2009-10 seasons
5. That the OAL review stipends for coaches and athletic directors in conjunction with contract negotiations; and
OUSD contract negotiations are ongoing
6. That the OAL give preference to high school site staff whenever possible for coaching positions; and
The OAL gives preference to high school site staff whenever possible for coaching positions;
7. That the OAL update all schedules and event start times:

That the OAL has held a planning retreat and updated schedules and event start times to:
Reduce losses of class time, increase parent participation, improve safety, improve transportation and improve access of scouts to games

8. That the OAL update and improve Financial Systems and Practices:

The OAL has updated and improved Financial Systems and Practices by
Implementing standard collection of gate receipts, deploying centrally assigned “Gate Teams” and identifying school individuals to assist in collecting and accounting for games receipts

9. That the OAL may seek sponsorships:

The OAL has secured sponsorships for a scoreboard, press box, and KDOL “OAL Legacy” programming and four “Game of the Week” broadcasts

10. That the OAL implement season tickets for company employees:

The OAL has implement season tickets sales for season passes not including championships

11. That the OAL pursue partnerships with the Oakland Technology Exchange (OTX) to provide home computers (desktops) for every OAL athletic who meets the criteria; and

The OAL has established a partnership with the Oakland Technology Exchange (OTX) to provide home computers (desktops) for every OAL athlete who meets the criteria

12. That the OAL establish the OAL Game of the Week on KDOL; and

The OAL has established the “Game of the Week” broadcasts for football and basketball
(as funding permits)

13. That the OAL improve adherence to CIF, OAL, and Oakland Section Rules:

The OAL has satisfactorily complied with all CIF, OAL, and Oakland Section rules, eligibility requirements, reporting, hardship hearings

14. That the OAL providing coaching professional development, clinics, conferences and screening:

The OAL has required successful completion of CIF coaching certification for all OAL paid coaching positions

15. That the OAL form partnerships with local colleges and universities for Sports Clinics/Camps; and

The OAL continues to establish partnerships with local colleges and universities including Laney, Merritt and UC Berkeley for Sports Clinics/Camps

16. That the Board of Education authorize the six high school principals on the Oakland Athletic League Policy Committee to annually identify and designate one other administrator for the school year as his/her alternate member on the OAL Policy Committee with full voting and participation rights in the absence of the principal at Committee meetings; that the Secretary of the Board is authorize to codify this authorization as an amendment to the OAL Bylaws at the appropriate section(s) therein; and

18. That the OAL request the Measure G Committee provide annual funding subsidy to the OAL;

**RECOMMENDATIONS FROM THE SPECIAL COMMITTEE ON THE
FUTURE OF THE OAKLAND ATHLETIC LEAGUE (OAL) INCLUDING BUT
NOT LIMITED TO THE OAL REMAINING A SECTION OF THE CALIFORNIA
INTERSCHOLASTIC FEDERATION**

WHEREAS, the President of the Board pursuant to Board Bylaw 9130, supported by a consensus of the majority of the members of the Board and the Interim Superintendent of Schools, appointed a Special Committee on the Future of the Oakland Athletic League (OAL), with a mandate that said Committee issue a report and recommendations to the full Board of Education on or about September 24, 2009, arising out of expressed public concern, among others, as to whether or not the League should join the North Coast Section of the California Interscholastic Federation (CIF) and if not what resources are needed and should be provided to the OAL to remake it a vibrant league supporting sports and physical education for District students,

WHEREAS, the Special Committee conducted a Public Hearing on said issues, among others, on August 21, 2008, in which more than three-fourths of speakers, recounted the long and proud history and identify of the OAL within the City of Oakland, noted the disadvantages of joining another section of CIF exceed benefits, urged the retention of the Oakland Athletic League as a section of CIF,

WHEREAS, the Special Committee on September 18, 2008, meeting in Public Session, considered the testimony received at the August 21 Meeting, recommendations received from members of the OAL Policy Committee which informally meet on September 17, 2008, from the OAL Commissioner, from the Interim Superintendent of Schools, from members of the Public, and from members of the Committee, hereby makes the following recommendations for consideration by the Board of Education:

1. That the OAL continue as a separate and distinct section of the California Interscholastic Federation (CIF); and

2. That the OAL monitor all OAL athletes through designation in AERIES on a weekly basis:
 - Eligibility
 - GPA
 - Attendance
 - Grade level progression
 - CASHEE
 - PSAT/SAT/ACT;
3. That the OAL require for OAL athletics academic assistance/enrichment outside of regular school hours (after school and Saturday) as needed;
4. The OAL move Soccer to Winter for Boys and Girls for the 2008-09, 2009-10 seasons;
5. That the OAL review stipends for coaches and athletic directors in conjunction with contract negotiations;
6. That the OAL give preference to high school site staff whenever possible for coaching positions;
7. That the OAL update all schedules and event start times:
 - Reduce losses of class time
 - Increase parent participation
 - Improve safety
 - Improve transportation
 - Improve access of scouts to games;
8. That the OAL update and improve the Financial Systems and Practices:
 - Utilize Armored car services for league games if feasible;
 - Implement standard collection of gate receipts
 - Uniforms purchases for the entire League for volume savings
 - Principals will identify school individuals to collect and account for games receipts;
9. That the OAL may seek sponsorships:
 - Championship games
 - Fields
 - Gymnasiums
 - Scoreboards;

10. That the OAL implement season tickets for company employees:
\$50 for season passes not including championships
\$75 for season passes not including championships after October 12, 2008;
11. That the OAL pursue partnerships with the Oakland Technology Exchange (OTX) to provide home computers (desktops) for every OAL athletic who meets the criteria;
12. That the OAL establish the OAL Game of the Week on KDOL;
13. That the OAL improve adherence to CIF, OAL, and Oakland Section Rules:
Eligibility;
Reporting;
Hardship Hearings
14. That the OAL providing coaching professional development, clinics, conferences and screening:
Athletic Director annual evaluation of players, parents and coaches
Evaluation of Athletic Directors by parents, students and principal
15. That the OAL form partnerships with local colleges and universities for Sports Clinics/Camps;
16. That the Board of Education authorize the six high school principals on the Oakland Athletic League Policy Committee to annually identify and designate one other administrator for the school year as his/her alternate member on the OAL Policy Committee with full voting and participation rights in the absence of the principal at Committee meetings; that the Secretary of the Board is authorize to codify this authorization as an amendment to the OAL Bylaws at the appropriate section(s) therein;
17. That the Superintendent of Schools shall conduct an annual evaluation of the OAL program and provide a report to the Governing Board; and
18. That the OAL request the Measure G Committee provide annual funding subsidy to the OAL;


