The new total amount after approval of prior BMFs or expenses is \$5,480.62.	<p>Travel and Conferences: Travel and conferences to pay for Lodging (hotel rooms) for the Public Health Academy pathway students' Overnight Field Trip to Sacramento.</p> <p>This experience, a three-day/2-night trip, will be one of the culminating activities of the students' Senior Projects. They will have several opportunities to apply their learning and research from the last three years to authentic interactions with various people who affect change in public health at the local and state legislative levels.</p> <p>These opportunities include: meeting with elected representatives (e.g. Mia Bonta, California State Assemblymember for District 18) who are working on critical public health issues and advocating for their ideas and needs that have been thoroughly researched in the fall semester, attending a session of the California State Legislature, visiting the California Railroad Museum to focus on the roles of women and the Chinese in the development in the railway, relative to the curriculum in American Government and their senior public health career-technical education course, and a workshop with a qualified, engaging presenter (former high school teacher and current CSU instructor) who will talk to students about personal finance and how to start early to build a stable financial future.</p> <p>Budget Calculation: The funds will cover part of this trip's lodging expenses (hotel). At approximately \$250 per night, this will cover 20 rooms for 2 nights (about 60 students and 6 teachers will attend).</p>	\$5,480.62

			<p>This is to pay for teachers to run the ECCCO summer internship program for all participating Oakland High students. These teachers host a weekly class for students that guides them through their internship experience. The rest of the time is spent visiting students at their internship sites to evaluate and support them as they complete this important experience. This position is critical to students' success in the program, as it serves as an adult liaison between students and the host organization. It helps ensure students meet required expectations and supports the host organization by ensuring interactions and expectations for students are appropriate. We estimate 110-120 Oakland High students will participate in ECCCO in the summer of 2025. We are allocating \$5,480.62 to this overall and will specify exact amounts per advisor once we know who is participating. (Salary, benefits, and Admin costs are included)</p>
