Karen Lozano, Program Manager Middles School Operations, affirmed Middle School Superintendent Hong's statement.

Julia Li stated that there will be 6th grade students participating in the Field Trip with the 5th graders to encourage camaraderie with Middle School students.

Chairperson Riley requested that AIPCS II revise their 2024-2025 Measure G1 Carryover Funding Request, specifically item 2. 5th grade Field Trip to

Chabot Space & Science Center, to further explain the connection of the 5th and 6th grade students during the Field Trip.
