
- 2. There shall be salary re-opener for all bargaining units for the Fiscal Year 2013 2014 and Fiscal Year 2014 2015.

The purpose of our review is to determine whether these agreements will have a material impact on the financial condition of the District in the current and subsequent two fiscal years.

The agreement represents an extension of a prior agreement through June 30, 2015. No cost increases were incurred by this agreement. Based on the District's 2014-15 Adopted Budget, it appears the District will continue to be able to meet the minimum reserve requirement through 2016-17.
