Tribute To Enasia Mc-Elvaine, Student Board Member, September 14, 2017 – June 30, 2018

WHEREAS, Enasia McElvaine has distinguished herself during the 2017-18 school year as a Student Director on the Oakland Board of Education, where student members are commonly referred to as “Student Directors”; and,

WHEREAS, Ms. McElvaine spent her entire high school career in the Oakland Unified School District and graduated from McClymonds High School on June 7, 2018; and,

WHEREAS, Ms. McElvaine became a Student Director to represent the youth voice of McClymonds High School and West Oakland and to join forces with the Board of Education to tear down obstacles that young people face; and,

WHEREAS, Ms McElvaine has been civically engaged as a CORO 2017 Youth Fellow Alumni and a commissioner on the Oakland Youth Advisory Commission. She also was on her school debate team in the Bay Area Urban Debate League and she visited and studied in Africa and Asia as part of school trips; and,

WHEREAS, Ms. McElvaine played a key role in the budget issues the Board and District faced this year, ensuring that student voice was heard and prioritized in the decision-making process; and,

WHEREAS, in her commitment to lifting up student voices and representing the young people of Oakland, Ms. McElvaine has exemplified the District’s core values of putting *Students First, Equity, Excellence, Integrity, Cultural Responsiveness* and *Joy*; and,

WHEREAS, Ms. McElvaine will attend Xavier University of Louisiana in the fall of 2018 where she will major in Pre-Med Biology with a minor in Global Health. She hopes to follow that with a medical degree which she plans to use not only in the Peace Corps battling malaria and HIV/AIDS but also as a pediatric surgeon here in Oakland continuing her work in service of Oakland’s young people; and,

WHEREAS, Ms. McElvaine’s resilience, passion, wisdom, leadership and civic commitment leave a tremendous legacy at McClymonds High School and offer a positive model for future students and Student Directors,

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the Oakland Unified School District, and Kyla Johnson-Trammell, Superintendent of Schools, acknowledges and honors Ms. Enasia Mc-Elvaine for outstanding service to her peers, her school, the District, and the Oakland community.
