

# 04-0463 District Budget Advisory Committee - Measure E Allocation Recommendations - Fiscal Year 2004/5

Adoption of 2004/05 DBAC Measure E Funding recommendations, based upon requests from the public, District staff and/or from Committee initiatives to the State Administrator and Board of Education in the areas:

To attract and retain qualified credentialed teachers \$4,685,000.00

To maintain elective courses for students needing 1,700,000.00

to qualify for college admission,

To purchase textbooks and materials 2,500,000.00

To maintain libraries, music and arts programs 2,262,000.00

To maintain reduced class sizes 7,566,549.00

\$18,713.549.00

with the State Administrator having flexibility within these allocations to make adjustments, as may be required, for negotiations to satisfy teacher adjustments and considerations.

The Committee and Staff had extensive discussions about the recommended funding. Chairperson Rapport called the question and the Committee voted upon the approval of the State Administrator's recommendation on the left side of the sheet totaling \$16,713,549. It carries the additional language that the State Administrator has flexibility within those programmed lined items to make adjustments in the dollar amount as needed for negations to satisfy the teacher adjustments and considerations.

Adoption of 2003/04 District Budget Advisory Committee Measure B Funding (Carry Over) Recommendation to the State Administrator and the Board of Education as follows:

Teacher Retention

\$909,000

Following extensive discussions, Chairperson Rapport called the question and the Committee voted as indicated herein. Fund the Case Managers, \$300,000; the AVID-High School, \$500,000; Advanced Placement Classes at \$1.2 million (divided roughly) \$700,000 for high school, \$500,000 for middle schools; \$40,000 for the Arts and the remainder in carry over.
